The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Georgia, Houston County

On this 31st day of July A.D. 1854 personally appeared before me John M. Chastain one of the Judges of the Inferior Court of Houston County and said State of Georgia, Charity Gamage a resident of Wellborn's Mills County of Houston and State of Georgia aged Eighty-nine years, who being first duly sworn according to Law doth on her oath make the following declaration in order to obtain the benefit of the provisions made by the act of Congress passed July 4th, 1836 and any other acts applicable;

That she was married to William Gamage who served in the defense of his Country in the Revolutionary War, according to her information & belief in a light horse Company in and from the County of Orange State of North Carolina previous to the close of the war, but the exact time of service not known That she had frequent conversations with him in which the spoke of being in battle and killing a Tory and of the manner of making a charge on the enemy on horseback, and that his father having come over from England, and in all probability having many relation amongst the British soldiers, I inquired of him how he could reconcile it to himself to be fighting his blood relations, he replied that he did not care for he was fighting for his Country and they against it and frequently heard him speaking in praise of his officers, and of a Captain Allen [Abraham Allen] and Captain Douglass [William Douglas] and of a Colonel Mabun [sic, probably Lt. Col. Robert Mebane] as being a choice man and who was waylaid and killed by a Tory, also heard him had many conversations with those who had served & overs relating to their suffering, dangers and privations some of their names I recollect (viz.) a Mr. Brooks who had been taken prisoner and kept in a prison ship sometime, and with John and Ned Couch¹ who the last I heard of them one of them lived near Hillsboro of N. C. who knows all about the Service of my husband. He had in possession the horse he served on and his sword and pistols which I well remember.

She further declares that she was married to the said William Gamage in the latter part of the year 1782 or forepart of 1783 and that he died in Wilkes County State of Georgia about the year 1809 or 1810 and that she still remains a widow which will more fully appear by reference to the proof annexed.
