Pension application of Alexander Gunn R4386 Transcribed by Will Graves Bedy Oak Gunn

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Georgia, County of Cass

On this the 10th day of November A.D. 1853 Personally appeared in open Court before the undersigned Thomas A. Word Ordinary in and for the County and State aforesaid Alexander C. Gunn a resident of the County of Cass and State of Georgia aged 49 years who being first duly sworn according to law doth on his Oath, make the following declaration, in order to obtain the benefit of the provision made by the act of Congress passed July 4th, 1836. That he is the Son of Alexander Gunn who was a private in the company commanded by Captain George Dowell in the Regiment commanded by Colonel Malmadey [Francis de Malmedy, Marquis of Bretagne] in the Revolutionary War and that the said Alexander Gunn resided in the County of Rowan in the State of North Carolina when he entered the Service and that he marched through said State and was at the battle of Eutaw Springs [September 8, 1781], And he further declares that the said Alexander Gunn died on the 8th day of August A.D. 1830 and that his Mother named Bedy Oak Gunn died on or about the 7th day of April A.D. 1845 and that they were married on or about the 13th day of September in the year 1791. And that their three other children of the said Alexander Gunn as follows: John M. Gunn, Jane Campbell and Mary Gunn only surviving Children of the said Alexander Gunn.

He hereby revokes any former Powers of Attorney that he may have given for the prosecution of the above claim for pension, and does by these Presents constitute and appoint irrevocably and with powers of Substitution William R. Query and Henry H. Walker of the County of Union and State of Georgia his true and lawful Attorneys for him and in his name and stead to examine into prosecute to demand and receive from the Government of the United States all his rights in any manner of claim or pension arrears of pension or land as Son of the said Alexander Gunn who died leaving the same undrawn as in right of law, custom or equity he is or may be entitled.

In Testimony Whereof he has on this day and Year first mentioned hereunto signed his name and affixed his Seal.

State of Georgia, County of Union

On this 22nd day of March A.D. 1845 before me Mason McLeod a Justice of the peace in and for the County and State aforesaid, Personally appeared William McLeod² a pensioner of the United States and a Resident of the County of Union and State of Georgia to me well known, who being duly Sworn according to law deposeth and saith on oath that he was well acquainted with Alexander Gunn who was a Revolutionary Soldier of the State of North Carolina and a Resident of Rowan County in said State, and Deponent States said Alexander Gunn was a private in the Company commanded by Captain George Dowell and was in Service with Deponent and continued in actual Service in said war for the term of four months and Deponent further states that he at the time of said War that said Alexander Gunn as Deponent heard and believes was in and Served one other Tour in said War, besides the one above mentioned And Deponent further states that said Alexander Gunn and Bedy Oak Gunn his wife that they must have been married in or about the year 1791, and that they always lived together as man and wife and was always Reputed so to be and that Witness never heard anything to the contrary.

And Deponent further states that Alexander C. Gunn who now makes application as Heir for the Pension Money due said Alexander Gunn and his wife Bedy Oak Gunn years and always was treated as and Deponent believes is the Son and Heir of Said Revolutionary Soldier and Deponent declares that he is not interested in said application to Pension.

State of Georgia, County of Fannin

On this 5th day of August A.D. 1854 Before me Coleman Forrester an acting Justice of the Peace in and for said County, personally appeared William McLeod a Pensioner of the United States and a resident of Fannin County in the State of Georgia, who being duly sworn according to law, deposeth and saith that he was well acquainted with Alexander Gunn who was a Revolutionary Soldier of North Carolina. That he knew said Alexander Gunn to be in the service of the United States about 4 months, and that he heard that said Alexander Gunn was in the service as aforesaid prior to the period he was with him, in said Service and deponent further states that the said Alexander Gunn was the identical Alexander Gunn, who served in said War, from Salisbury District, and that he is the only person of that name that did so serve in or from that District or that he ever heard of in America. He further states that said Alexander Gunn came from Scotland in the same Ship he did himself and that he is the identical Alexander Gunn who married Bedy Oak Gwin.

And deponent further states that he was acquainted with Alexander C. Gunn who now claims a pension, in right of said Alexander Gunn deceased and that he was always, by him treated as it is by the Witness believed to be the son and heir of the said Alexander Gunn, And deponent further states that he served from Salisbury District and that he is in no wise interested in the Berg execution or result of the Claim of Bedy Oak Gunn to pension.

State of Georgia Cass County

On this 19th day of April A.D. 1856 personally appeared before me an Acting Justice of the Peace in and for said County Alexander C Gunn a Resident of said County who being duly sworn according to law declares upon his Oath, that the leaf of the old family Bible of Alexander Gunn deceased on which was a record of the Marriage of Bedy Oak Gone to the said Alexander Gunn deceased was in his own handwriting, which Record has remained in the possession of the Heirs of the said Alexander Gunn deceased without any alteration whatever with the exception of writing upon a part of the said family Record with the new and black Ink where the writing had almost become invisible, and that there was no word or words, letter or letters added to order diminished from said family Record for the purpose of altering it but declares that the black Ink was run over that part of said Record where the writing had become almost invisible for the purpose of preserving the same, as it was originally written by the deceased Soldier, and he further states that said Record was newly written as above described long prior to the time of making Application for this pension of said Bedy Oak Gunn deceased or long before he knew that he or the above named claimant was entitled to a pension and that said record is the original.


