Pension application of John Hamilton R4516 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Logan County October the 30th 1834 [State of Virginia]

We the undersigned Justices of the peace for the County of Logan in the State of Virginia do hereby certify that at the request of John Hamilton, who from old age and infirmity is unable to attend at the Courthouse of the County: We have therefore met him at the House of Edward Chapman, near his place of residence: And after He the said Hamilton having been duly sworn, Made the following declaration; in order to obtain the benefit of an Act passed by Congress on the 7th day of June in the year 1832. That he enlisted into the Seventh Regiment of North Carolina Militia: and was placed in the Company commanded by Captain John Griffith with which Regiment he continued for two months: when he volunteered into the light Infantry of the line, and served in the Company of Captain Archibald Little [Archibald Lytle]; the Company was then stationed at Pruningsburg [Purrysburg] in North Carolina [sic, South Carolina] from whence he was marched to Augusta in Georgia, was under the orders of General Sumpter [Thomas Sumter] at the Savannah, with the British on Briar Creek [March 3, 1779]; after our defeat in this affair we marched to White House in Carolina; after continuing at this post some time, we joined the Army at Pruningsburg and served with the light Infantry in many services; until he was discharged near Charleston late in the year 1779. He never received any pay for his services, except \$5 received as bounty when he entered the light Infantry Regiment.

Questions put by the undersigned Justices to John Hamilton

O Where and when were you born?

Answer. I was born in the year 1756 in the County of Chester in the State of Pennsylvania Question. Have you any record of your Age?

Answer, no: my knowledge is traditionary.

Question. Where were you living when called into service, where have you lived since the Revolutionary War & where do you now live?

Answer. I lived in North Carolina when I entered the service after the revolutionary War I moved into Montgomery County Virginia and have lived in Logan County Virginia for the last 10 years –

Question. How were you called into service, were you drafted, did you Volunteer, or were you a Substitute, and if a Substitute for whom?

Answer. I enlisted first & served 2 months in the Militia, then volunteered into the light Infantry or rifle service, where I continued 7 or 8 months.

Question. State the names of some of the Regular officers, who were with the troops where you served, such Continental and Militia regiments as you can recollect; and the general circumstances of your service?

Answer. I remember General Sumpter, Lieutenant Colonel James Thackston and Major

Dickson: besides the other officers names given in my declaration

Question. Did you ever receive a Discharge & if so by whom was it given; and what has become of it?

Answer. I received a Discharge from Lieutenant Colonel James Thackston which I carried in my pocket book until it literally wore away

Sworn to and answered before us this 30th day of October 1834

He relinquishes all claim to any pension but the present & declares that his name is not on any pension roll in any State in the Union

Personally appeared before the Subscriber a Justice of the peace, for the County aforesaid John McLaughlin³ and made oath in due form of law & states that he was acquainted with John Hamilton now of the County of Logan in the State during the war of our Revolution and served with him in the 7th Regiment in the Company of Captain Griffith until they joined the light Infantry under Captain Archibald Little [Archibald Lytle] at Pruningsburg [Purrysburg] in South Carolina was present at the Skirmish with the British on Briar Creek hours troops were commanded by General Sumter James Thackston was Lieutenant in the Company of Light Infantry believe said Hamilton served at least nine months & further deponent saith not – Given under my hand & seal this 28th day of August 1836
