## Pension application of William Hansard R4580 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

On this 14<sup>th</sup> day of December 1843 personally appeared in open Court before the Court now sitting for said County and State aforesaid Mr. William Hansard a resident of said County aged 80 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed July 7<sup>th</sup> 1832 [June 7, 1832]. That he entered the service of the United States in the War of the Revolution in the year 1781 in the County of Bedford in the State of Virginia under the following named Officers Captain John Cottrel and guarded the Tories in the Town of New London in said State of Virginia for 6 months. He hereby relinquishes all claim whatever to a pension or annuity except the present and declares that his name is not on the Pension roll of the agency of any State.
