Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." South Carolina Spartanburg District} to wit

On this 7th day of March 1833 personally appeared in open Court, to wit, the Court of Sessions and common Pleas, before the Judge of the said Court now sitting, Charles Hester, a resident of the District aforesaid aged Eighty-six years who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the benefit of the act of Congress passed June 7, 1832 – That he entered the Service of the United States under the following named officers and served as herein stated. - "I entered the service of the United States, in June 1776 in the drafted militia of this State, in the Company of Captain William Tate, in Spartanburg District, South Carolina in the Regiment commanded by Colonel Wofford [William Wofford, Sr.] for six months, during which time I was generally employed, as a Smith, in shoeing horses and other Smith work for the Regiment – I afterwards served in the Company of Captain George Taylor in Colonel John Thomas's Regiment for the space of one year, still employed generally as an artisan for the Army –. I never was in any battles – nor did I ever obtain any regular discharge - I have no documentary evidence of my discharge, nor do I know of any person now alive in this State, who knew me in the Revolution – I do hereby relinquish every claim to a pension or annuity except the present and declare that my name is not on the pension Roll of the agency of any State. – In answer to the questions propounded by the Court - I answer 1st I was born on the 16th of August 1747 in Louisa County Virginia as I have been informed by my ancestors – having no record in my possession. 3rd, 4th, & 6th see within – seventh I refer to the Reverend Joshua Richards, Elijah Turner and Allen Turner who will certify

^{1&}lt;sup>st</sup> Where and in what year were you born?

^{2&}lt;sup>nd</sup> Have you any record of your age and if so where is it?

^{3&}lt;sup>rd</sup> Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

^{4&}lt;sup>th</sup> How were you called into service; were you drafted; did you volunteer or were you a substitute, and if a substitute, for whom?

^{5&}lt;sup>th</sup> State the names of some of the regular officers who were with the troops where you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.

^{6&}lt;sup>th</sup> Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it? 7th State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.
