[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky Casey County: SS

On this the 14th day of September A.D. 1829 Personally appeared in Court being a Court of Record for the County of Casey & State aforesaid and established by Statute under the Constitution of the aforesaid State, Andrew Hogue, resident citizen of said County about sixty-seven years of age, who being first duly sworn according to law – doth on his oath, make the following declaration in order to obtain the provision made by the acts of Congress of the 18th March 1818 and the 1st May 1820 that he the said Andrew Hogue enlisted for the term of twelve months on the 27th day of February 1782 in the State of North Carolina in the company commanded by Captain Samuel Jones in the Regiment commanded by Colonel John Armstrong & Archer Litle [Archibald Lytle] in the line of the State of North Carolina on the Continental establishment. That he continued to serve in said Corps for the twelve months, when he was discharged by Major Thomas Donnieho [Thomas Donoho] and his discharge he has lost or misplaced. That he hereby relinquishes every claim whatever to a pension except the present that his name is not on the Roll of any State (except the State of Kentucky) And that the following all the reasons for not making earlier application for a pension, to wit, That in the year 18__an affidavit was made & duly certified which he placed in the hands of a friend which was lost & misplaced and the absence & difficulty of making proof sense of his service etc. with the failure in proof of an application before in this year has prevented earlier application – And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled “an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war” passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. 75 acres of

land worth 2\$00 [sic] is 150\$ [sic] 25 acres land worth 75\$ 50 acres land worth 12\$50 21 hogs worth 15\$ 14 sheep worth \$7.00 One mare & Colt worth 35\$ & One Cow & Calf worth 6\$. Total Value #00\$50 cents

That since the 18th of March 1818 the following changes have been made in my property. One cupboard one table 2 cows one colt & one pot of the value of 30\$ given to my daughter & such property as I then & since have [indecipherable word] I do not recollect particularly – And all have been disposed of for the use of myself and family in consumption & the pavements of my just debts. He states his occupation is farming. That from his age and bodily disability he is unable to labor but little. That he has a wife & one child a daughter with him his wife's name is Alley page 65 years his child's name is Polly aged 17 years neither of whom are much enabled to aid him in his occupation.

Sworn to & declared on the day & date above written before the Justices of the County Court for the County of Casey & State of Kentucky.

State of Kentucky Casey County June 18th 1828

This day came John Carney¹ being eighty-six years of age before John Riffe and John Fitzpatrick 2 of the Commonwealth's Justices of the peace for Casey County and after being duly sworn according to law depose and saith that he the said John Carney was a private soldier in the North Carolina Continental establishment and that Andrew Hogue (who is now present with me) was enlisted by Charles Dixon Lieutenant on the same day which was on or about the 27th day of February 1782 & was marched into head quarters under Captain Robert Fenner, and that I the said John Carney was well acquainted with the above mentioned Andrew Hogue before his enlistment and now well know him to be the identical same man. I William Hill Secretary of State in and for the State aforesaid do certify it appears from the muster rolls of the Continental line of this State in the Revolutionary War that Andrew Hogg a private Soldier in Captain Jones's Company of the 10th Regiment enlisted on the 8th day of February 1782 for the term of 12 months, that nothing more is said of him on said rolls, it is therefore believed that he served the term for which he enlisted.



[fn p. 3: On April 8, 1844 in Casey County Kentucky, Alley Hogue, 78, filed for a widow's pension under the 1838 act stating that she is the widow of Andrew Hogue, a pensioner for his service in the revolution; that she married him March 24, 1785; that her husband died July 29, 1838; and that she remains his widow.

[fn p. 39: In January 1855 in Lincoln County Kentucky, Deboria Smith, late Deboria Basten, [Deborah Smith/Deborah Basten] 79, gave testimony that she married her first husband Baston in Caswell County North Carolina in the year 1794 and lived in said County for many years; before her marriage to Baston she was personally well acquainted with Andrew Hogue and Alley Hogue in said Caswell County; that they ran off to get married and returned and lived together as man and wife; that Alley Hogue prior to her marriage was Alley Murry.]

[Veteran was pensioned at the rate of \$8 per month commencing February 19, 1831, for one-year service as a private in the North Carolina Continental line.]
