[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Virginia, Scott County

On this 29<sup>th</sup> day of September A.D. 1858, before me Ansel F. Gilliam a Justice of the Peace of and for the County and State aforesaid, personally came Becky Killion aged 90 years a resident of Scott County in the State of Virginia who being duly sworn according to law, declares that she is the widow of John Killion deceased who was a soldier and drafted for the whole term of the revolutionary war seven years. The company she does not recollect nor the regiments the officers names were Hogg & Donohue [sic, Thomas Donoho?]. He was drafted from Stokes County North Carolina and served his time out and was honorably discharged the day and year she does not recollect as his discharge has been lost as well as his land warrant. She further declares that her said husband was in the battles of the Horse Shoe, Two Sisters, Guilford Court House, Monks old Field and other places she does not recollect. That the said John Gilliam was wounded in the shoulder, and his father Michel Killion<sup>1</sup> was killed, both served together. She further declares that the said John Killion received nothing, but his land warrant the best of her recollection, and that he or herself received anything from the same.

She further states that she was married to the said John Killion on the \_\_ day of \_\_ A.D. by one William Dobson of Morren's [?] Cross Roads Stokes County North Carolina and that her name before her marriage was Becky Wilborn [?] that her said husband died at Surry County North Carolina on the \_\_ day of February 1816 A.D.; and that she is now a widow.

She further declares that she has never made any application for her pension or Bounty Land under any of the acts of Congress except the one above mentioned as received by her husband John Killion and further says she is entitled to the pension of John Killion's Fall or Michel Killion as the sole heir now living.

We William Campbell and \_\_ residents of Scott County upon our oaths declare that we were personally acquainted with John Killion and Becky Killion during the lifetime of the said John Killion husband of the said Becky Killion and we know that the said John Killion and Becky Killion lived together as husband and wife and were regarded and reputed by their neighbors that the said John Killion is dead that the said Becky Killion is still his widow and that we have no interest in this claim.
