Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]


John Kindrick of Monroe County State of Mississippi aged 84 years 25 December next – entered the service of the United States as a militia man in Pittsylvania County State of Virginia between the middle & close of the revolutionary War under Captain Witcher Lieutenant Robert Daulton, Major Waid – Colonel Mason of South Carolina – three months tour – Went to South Carolina was at the battle of Stono [June 20, 1779] – General Lincoln [Benjamin Lincoln] commanded – returned home after getting his discharge from Colonel Mason or Lieutenant Colonel Burrell – Supposing his discharge would be of no advantage did not retain it –

2. In about six months entered the service again in said County under Captain Armistead Shelton, Colonel Williams, Major Rose Rope was a regular officer who took command at Ninety Six in South Carolina went with them to the High Hills of Santee at the time they were retreating from Lord Roddon [Rawdon] – was at the battle of Ninety Six – served this tour six months – There is no person by whom he can now prove his service.

He knew Major Rose & Colonel Lea of the regulars also Colonel Washington Colonel Lea was of the light infantry & had also a horse company – Colonel Washington was of the horse – Colonel Lea came to relief of 96 but had to retreat from Lord Rodden from Charleston.

Six or eight years after the revolutionary war moved to Columbia Georgia remained there until 15 or 16 years ago – Moved to Limestone County Alabama remained there till within three years past – since which time he has occasionally been in Limestone County Alabama & Monroe County Mississippi – now resides in Monroe County Mississippi –
