[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]


On this 16th day of July 1847 personally appeared before me, James Kuykendall, Clerk of the Court of Common Pleas for the said District & at the office of the said Clerk James Moore, a resident of the District and State aforesaid aged Eighty-five years, who being first duly sworn according to law, doth, on his oath, make the following declaration in order to obtain the benefit of the provision made the act of Congress passed the 7th of June 1832, granting pensions to Soldiers of the American Revolution.

That this declarant was a private Soldier in the South Carolina Militia during a portion of the Revolution. That his first tour of duty commenced in the early part of the year 1782, he was drafted in the service for three months under Lieutenant James Wallace Colonel Bratton's [William Bratton's] Regiment, that they left home (now York District) and was marched to down to Orangeburg where they took up their quarters and remained till the Spring, and until his three months draft expired which was in the month of April and he was discharged. His next and second Tour was under Colonel Bratton in the summer following, and in 1782, he served three months a scouting about through the Country keeping down the disaffected &c which was the closing up of the difficulties of the war.

This declarant further states that his name is not on any pension Roll of the United States, and that he hereby relinquishes his claim to any and all claims except the present, and that the reason for his delaying his application till the present time is, that at the time others were applying there was not much due him, and he thought he would try to live without it, and that the number of years having passed since the passage of the law, the amount now due has become a matter of some consideration.
