[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of South Carolina District of Marion: SS

On this 30th day of December 1840 personally appeared Ann Rogers (before the subscriber, Justice of the quorum Ex officio) a resident of South Carolina in the District of Marion aged eighty-six years who being first duly sworn according to law doth on her oath make the following Declaration, in order to obtain the benefit of the provision made by the act of Congress passed July 4th, 1836. That she is the widow of Lott Rogers who was a private in the Army of the Revolutionary war. – That he her husband entered the service some considerable time after the Commencement of the Struggle, that her husband was drafted for three months, and served out the same time and one month over. – That her husband marched as she understood to attend his services at the Battle of the Brandywine [September 11, 1777] – that her husband & self resided in the State of Virginia at the time he entered the service – She further declares that she was married in the month of apl. [April?]¹ 11th 1773 – that she was the Mother of 2 children during the said Revolution, by virtue of said Marriage with the said Lott Rogers. – That her husband the aforesaid Lott Rogers died on the 2nd day of April 1828 – and that she has remained a widow ever since that period, as will more fully appear by reference to the Proof hereto annexed.


South Carolina Marion District: SS

Levi Odom² personally appeared before me and made oath that he is well acquainted with the within named Ann Rogers – that she is a woman of strict truth. – That he knows she was married to Lott Rogers at the time specified in her Declaration, that the marriage ceremony was performed by one Christopher Reddick a Justice of the peace – for that he, this Deponent, partook of the wedding dinner at the house of the Father of the said Lott Rogers, That said Lott Rogers was drafted as a private in the service of the United States and served a part of his term with this deponent, who was marched to joined the forces under General Gates at Camden, but did not reach there until the Battle was over – that their Captain was named Jethro Sumner, – who commanded both this Deponent and the said Lott Rogers in our Revolutionary Struggle for Independence.
