[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Mecklenburg County

On this 26th day of February 1833 personally appeared in Open Court James Sloan before the Justices of the Court of Pleas and Quarter Session now sitting for the County of Mecklenburg & State of North Carolina and after being duly sworn doth on his oath make the following testament in order to obtain the benefit of the Act of Congress passed June 7th, 1832.

I was born in the State of Pennsylvania in the year 1761. My parents removed to Mecklenburg County when I was young. I entered the service of the United States in the year 1780 under General Rutherford [Griffith Rutherford] & Col. Locke [Frances Locke], Stephen Alexander Capt. In this Tour I served there nearly three months, in this Tour I served as a volunteer. I then [re]turned again as a volunteer for ~~six~~ three months. I served under General Green [sic, Nathanael Greene], Capt. Potts [Jonathan Potts] & was in the Battle of Guilford old Court House [March 15, 1781]¹ and then in the year 1781 I enlisted with Capt. Moore [Francis Moore], Maj. Moore, was placed in Col. Middleton's [sic, Charles S. Myddelton's] Regiment for ten months and was marched into the State of South Carolina & joined General Sumpter [sic, Thomas Sumter], was at the taking of Orangeburg [May 11, 1781],² from thence to near Columbia & there took Thompson's Fort [February 22, 1781],³ we then marched on & was in Middleton's defeat [June 18, 1781],⁴ from that marched on to Eutaw and was in the Battle at that place [Eutaw Springs, September 8, 1781].⁵ I served this tour ten months & was discharged. I have no documentary evidence having long since Lost my discharges. I hereby Relinquish Every Claim to a Pension or annuity, except the present under the Act of Congress passed June 7th, 1832 and declare that my name is not on the Pension Roll of the Agency of any State. 1. Where & in what year were you born

I was born in the State of Pennsylvania in the year 1761.

2. Have you any record of your age

I first served three months volunteer & again served three months volunteer. I then enlisted for ten months.




State of North Carolina, Mecklenburg County

On this 26th day of November 1833 personally appeared in Open Court before the Justices of the Court of Pleas & Quarter sessions for the State & County above written Capt William Alexander⁸ a resident of the County & State above written aged 84 and after being duly sworn makes the following statement: I was authorized to raise a Company of enlisted men for ten months. Capt Moore was also authorized, among the men enlisted by Moore the before mentioned applicant James Sloan was one. This was in the year 1781 I saw him in the service under Col. Middleton & General Sumter. I believe he served his full term.

[p 8: On April 25, 1846 in Cabarrus County North Carolina, William Slone [sic] filed a claim under the 1843 act for the pension due his mother Frances Slone as the widow of James Slone, a pensioner at the rate of \$52 per annum for his service in the revolution; that his parents were married in 1786; that his father died February 20th 1839 and that his mother died August 15th 1843 having remained a widow after the death of his father; that he knows of no record of the marriage of his parents or the dates of the births of their children; that the heirs of her mother who survived her are Nancy Ervin, Thomas Slone, Jane Ervin, Elizabeth Dewest[?], and Mary Ferrell (and himself, but not listed); that Thomas lives in Tennessee and Jane Ervin and Elizabeth Dewest live in Alabama and Nancy Ervin and Mary Ferrell live in Mecklenburg County North Carolina



[p 10: On April 27, 1846, Jane Davis testified in Mecklenburg County that she was well acquainted with James and Frances Stone [sic]; that they were married in the spring of 1787 which he knows because she herself was married in 1788 and has a record of her marriage.]

[p 11: on August 2nd, 1853 in Mecklenburg County North Carolina, Jane Davis, 85, gave testimony that she is the sister of James Sloan; that she has a distinct recollection of her brother James marriage with Frances Brown in the spring of the year 1787; that the date of their marriage is fixed in her mind because she herself was married about one year after her brother married Frances Brown; that her brother and Frances ran away and got married; that she was "one of the company who went along with her brother James Sloan to steal away his wife or rather his intended, that after getting possession of her they went to a neighbors house by the name of James Meek who was a magistrate and there the marriage ceremony was performed by Meek; that James and his wife had a child about 3 weeks old when she, deponent, was married in the month of February 1788; that Frances Sloan died in the year 1843 survived by the following children: Mary Sloan (married to James Ferrell) also, William B Sloan, who are the only children of the aforesaid James and Frances Sloan known to be living.]

[p 40: On January 8, 1848 in Mecklenburg County North Carolina, William Ferrell gave testimony that he has good reason to believe that James and Frances Slone were married prior to the year 1794 from the fact that he has a record of his age which shows that he was born June 13, 1785; that his father settled within one mile of James Slone and his wife Frances at which time they had seven children to wit, John, Nancy, Jane, Benjamin etc. and believes that her oldest son John was more than 3 years younger than himself

[p 46: Finding by the clerk of court for Mecklenburg County that Frances Sloan died a widow of James Sloan and was survived by the following heirs: Nancy who intermarried with Reuben Ervin; Thomas Slone, Elizabeth who intermarried with Aaron Deweast, Jane who intermarried with Silas Ervin, Mary who intermarried with James Ferrell and William B Slone all of full age.]


[Veteran was pensioned at the rate of \$53.33 per annum commencing March 4th, 1831 for 16 months service as a private in the North Carolina militia.]

Myddelton’s] Regiment Sumpter’s [Thomas Sumter’s] Brigade this our Indented Certificate for the Sum of Ninety-four pounds Sterling being amount pay and bounty due him for Services in that Troop Together with Interest thereon from the first April 1782 to date hereof Agreeable to Resolution of General Assembly of the Eleventh March last.”]

Middleton nor Captain Moore may attend, or should they, it will be troublesome for me to call on them to receive anything from them as they live at a ^{large} distance from me should there be Indents given at this time you will oblige me much in sending mine with the bearer Mr. Alexander Kennedy and his Receipt shall be Sufficient. Your compliance will much oblige your Humble Servant
