Pension Application of Bingamond Barnes (Barnes) S12970

Transcribed and annotated by C. Leon Harris

State of Kentucky Gallatin county sct.

On this 10th day of September 1832 personally appeared in open court before the Justices of the County court of Gallatin county being a court of record & now sitting – Bingamond Barnes a resident of Gallatin county & state of Kentucky, aged sixty seven the first day of next February, who being first duly sworn according to Law doth on his oath make the following declaration in order to obtain the Benifit of the act of congress passed 7th June 1832.

That he entered the service of the united states under the following named officers & served as herein stated. That he entered the service in the March 1781 under Capt. H. Reed [probably Henry Read] or Stanton [possibly William Staunton] – he does not recollect which one – that he entered as a substitute for his farther Francis Barnes [sic: Francis Barnes]. That his Farther was drafted for a tour of three months & he took his place. That he lived in the county of Culpeper in the state of Virginia when he entered the army. That he joined the army at the Wilderness Bridge in orange county Virginia. LaFayette [sic: Lafayette] commanded & John Therton [sic: John Thornton] was Col. That the ary marched to the raccoon ford rapidan river where Gen'l. Wayne joined the ary [Anthony Wayne, 10 Jun 1781] – Mulinburg [sic: Gen. Peter Muhlenberg] was also in army. The ary marched from the Fall to Richmond & marched on still below to a place called the Mobbin Hill [sic: Malvern Hill 15 mi SE of Richmond] where he was discharged sometime in June. That he was in no Battle. That in a short time afterwards he again entered the service as a substitute for a man named Watts, under Col. [Elias] Edmonds & Capt. Yancy [probably Lewis Yancey] that Watts was drafted for six months – and that he took his place & joined the army at Springfield below Williamsburg & continued in the army until it marched down to York & was at the sege & taking of Cornwallis [Siege of Yorktown, 28 Sep - 19 Oct 1781] & was after the Battle sent up with the prisners to Winchester Barrax where he was discharged having served three months He states that in the Two tours that he served six months in the Virginia mulitia & that he has no documentary evidence of his service & knows of no person by whom he can prove his services whose testimony he can procure except Shadrack Barnes [Shadrach Barnes, pension application S30840] who served with him.

I hereby relinquish every claim whatever to a pension or annuity except the present & declare & declare that my name is not on the pension roll of the agency of any states.

On this 10th September 1832 personally appeared in open court before the county court of Gallatin county aforesaid Shadrack Barnes & on his oath doth declair that he served in the army of the united states, Two Tours of three months each in the year 1781 & previous to the surrender of Cornwallis with Bingamond Barnes who has sworn to & subscribed the above declaration & that said B. Barnes did serve as he has stated in his said declaration. Sworn to & subscribed the day & year aforesaid

NOTE: On 19 July 1837 William Barnes of Bedford in Trimble County KY, one of the heirs of Bingamon Barnes, requested instructions for correcting the pension certificate, which had been erroneously issued in the name of Benjamin Barnes.
