

On this 20th day of Novr 1832 personally appeared in open court, before the County Court of Garrard County now in session John Floyd a resident Citizen of said county aged about 72 years, who being first duly sworn doth on his oath make the following declaration in order to obtain the benefit of the act of Congress pass'd 7th June 1832. That he served in the war of the Revolution, as a Militia soldier, ten months in the state of Virginia, as follows. In the year 1779 he entered the service of the U States in the County of King William State of Virginia as a volunteer for two months under Capn. David Pannell [David Pannell (Pannill), pension application VAS117], and serv'd out his time He does not remember the names of his other officers. That he again in the 1780 serv'd as a volunteer from the same county four months, the time for which he engaged, under Capn. Quarles, Kill Patrick [Kilpatrick?] was his Maj'r, and Innis [sic: James Innes] his Col.

He was marched to Williamsburg Virg'a, he remained there however but a short time, before he was marched to Hampton, where he finished the period of his engagement.

He again volunteered under Cap'n David Jimmerson [David Jameson?], and serv'd one month. Quarles was his Maj'r [Holt] Richardson his Col., and he was attached to Ge'l. Lawsons [Robert Lawson's] Brigade He went this Tour from the county of Caroline state of Virginia, and before he returned home, he again volunteered at the Mauben Hills [sic: Malvern Hill, 15 mi SE of Richmond], (there being a call for volunteers,) for three months, under Capn. D. Jimmerson, Stephens was Majr, Innis Col., – They were attached to the Command of the Marquis La Fayette [Lafayette]. He serv'd. all his tours of duty faithfully but has no written evidence of the same, yet he can establish all the facts, by his brother George Floyd [pension application S13041], who served with him every tour herein enumerated & set forth.

He hereby relinquishes every claim whatever to a Pension, except the present, and declares that his name is not on the Pension roll of the agency of any State. sworn to & subscribed.

He was marched to Williamsburg Virginia. He remained there however a short time before he was marched to Hampton where he finished the period of his engagement.

He again volunteered under Capn. David Jimmerson and served one month. Quarles was his major and Richardson his Col. And he was attached to Genl. Lawson's brigade. He went this tour from the county of Caroline State of Virginia before he returned home. He again volunteered at the Maubin Hills (there

[p7] being a call for volunteers for three months under Capn. D. Jimmerson, Stephen was major, Innis Col. They were attached to the command of the Marquis La Fayette. He served all his tours of duty faithfully but has no written evidence of the same, yet he can establish all the facts by his brother George Floyd who served with him every tour herein enumerated & set forth.

He hereby relinquishes every claim whatever to a pension except the present and declares that his name is not on the pension roll of the agency of any state. Sworn to & subscribed.
