[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky, County of Spencer

On the 10<sup>th</sup> day of September 1832, personally appearing in open Court before Justices of the County Court of Spencer County now sitting Anthony Crafton a resident in the County of Spencer and State of Kentucky, Aged Eighty five years who being first duly sworn according to Law doth on his oath make the following Declarations in order to obtain the benefit of the act of Congress passed June the 7<sup>th</sup> 1832, that he was drafted for a three months tour of duty in the County of Lunenburg and State of Virginia in the month of May in the year of 1778 and Served the same at Portsmouth and Hampton under Josiah Morton as Captain and was discharged in the month of September in the year of 1778. He does not recollect the names of any of the officers in Service during the aforesaid expedition; also that he volunteered for a three months tour in the County of Lunenburg & State of Virginia in the month of January 1781, under Sylvester Walker as his Captain & James Speed as his Ensign, was marched toward the South, was in battle of Guilford courthouse fought on the 15 of March 1781 under General Greene [Nathanael Greene] as Commander in Chief. Recollects that General Lawson [Robert Lawson] and Colonels Lee [Henry "Light Horse Harry" Lee] and Washington [William Washington] were in command while he was in service, and was discharged in the month of April 1781, but can't say the day nor the place. He states that he recollects written discharge from the service aforesaid, but that they are destroyed by time and accident and that he knows of no person whose testimony he can procure, who can testify to his services He states he was born the county of King William in the State of Virginia in the year 1747, the month not recollected. He had a record of his age, but it has been destroyed some years since, moved from the County of King William to the County of Lunenburg in the year 1771. In the year 1784, he moved to the State of South Carolina and then moved back to the County of Charlotte State of Virginia in the year 1785, where he lived until about the year 1796 or 1797. He moved from thence to the State of Kentucky, settled in the County of Lincoln, since which time he has resided in the Counties of Lincoln, Nelson, Shelby in said state and about five months since moved into Spencer County where he now resides. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares his name is not on the pension rolls of the agency of any state.

[Veteran was pensioned at the rate of \$20 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 6 months in the Virginia militia.]
