[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]



Application for a New Certificate
County of Giles State of Tennessee

On this thirteenth day of March 1822; before me, the subscriber, a Justice of the Peace for the said County of Giles State of Tennessee personally appeared Thomas McKissack that who, on his oath, declares that he is the same person who formerly belonged to the company commanded by Capt. Ballard [Kedar Ballard]-- in the Regiment commanded by Col. Patton [John Patten] -- in the service of the United States; that his name was placed on the pension roll of the state of North Carolina -- that he never received a certificate of that fact, under the signature and seal of the Secretary of War;

In the Army of the United States. Inscribed on the roll of the No. Carolina Agency at the rate of \$3 increased to \$4.80 per month by the Law 24 April 1816. Formal certificate issued 8 April 1822 and sent to German Lester Esquire Pulaski Tennessee

On March 6, 1930, Earl D. Church, Commissioner of pensions wrote a letter which reads as follows:

"I advise you from the Revolutionary War records of this Bureau it appears that Thomas McKissack (pensioned as McKissick) served in Capt. Ballard's Company, Col. Patton's Regiment

of the North Carolina Troops during the War of the Revolution. He was pensioned for disability. The nature of the disability and the manner of incurrence are not stated.

In 1822 he was living in Giles County, Tennessee, having lately moved there from North Carolina.

There is no further data on file in regard to this soldier.

To the above noted is the history of the only soldier by the name of Thomas McKissack act who is found on the Revolutionary War records of this Bureau,....
