Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Missouri County of Ralls: SS

On the \_\_ day of August personally appeared before the County Court while in Session Robert Jamison a resident of said County of Ralls & State of Missouri aged \_\_ years who being first duly sworn in open court according to law doth on his oath make the following declaration in order to obtain the Benefit of the provision made by the act of Congress passed June 7<sup>th</sup> 1832. That he entered the service of the United States as a militia man of the Virginia Line & served in the Regiment not recollected under the following named officers (viz.)

I was born in Augusta County State of Virginia A.D. 1762

Have you any record of your age

I have my father's record of my age

Where were you living when called into service where have you lived since the revolutionary war and where do you now live

I was living in Augusta County Virginia when I entered the service I am now living in Ralls County State of Missouri & a part of my time in Kentucky

how were you called into service were you drafted did you volunteer or were you a substitute & if a substitute for whom

I was in the year 1777 a substitute in place of Robert McChenney a 3 months service in 1781 I was drafted for a 3 months service

State the names of some of the regular officers who were with the troops where you served such Continental Regiments as you can recollect & the general circumstances of your service.

We joined General Wayne a regular officer Answer. I don't recollect any other militia of Regiments

Did you ever receive a discharge from the service & if so by whom was it given and what became of it

I received a discharge from my Captains but I have lost it I never received a Commission I refer Major Caldwell & Judge Chitwood who can testify as to my character for veracity & their belief of my services.
