[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

South Carolina, Orangeburg District: To Wit –

On this day the twenty Sixth day of March in the year 1833, personally appeared in open Court before John S. Richardson one of the Judges of the Court of General Sessions & Common Pleas, now sitting, Jeremiah Jones a resident of Orangeburg District in the State of South Carolina in born in the said District & State aforesaid on the 27th day of December 1759 & now in the seventy third year of his age who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th, 1832 --


That he entered the service of the United States as a volunteer under Captain John Stanfield [a North Carolina militia officer from Randolph County North Carolina] and served but a short time he does not remember the date or the length of time but believes for only five or six days as a private. That he entered again into service under Captain James Fair [James Farr] about the time General Greene [Nathanael Greene] came to the State and served in a horse Company three months as a private. That he was drafted under Colonel Thomas Wade and served to his recollection three months as a private -- That he entered the service again under General Marion [Francis Marion] & continued under him to be in of the war, which term of service lasted four months as a private & that he has no documentary evidence to prove the same. --

He hereby relinquishes every claim whatever to a pension or annuity, except the present, and he declares that his name is not on the Pension Roll of any Agency in any State.

Personally came before me Silas Haly who being duly sworn made oath that he knew Jeremiah Jones in the Revolutionary War & Served with him as a volunteer Soldier under Captain Fair -- for three months -- That he (the deponent) & the said Jones were in an

engagement near Lynches Creek [probably the engagement at Lynches Creek on March 6, 1781]¹ under General Sumter [Thomas Sumter] -- The deponent further saith that to the best of his knowledge they were to receive as a bounty \$25 & \$20 per month -- each Soldier furnishing his own horse & arms.





Personally came Peter DuBose⁴ before me & being duly sworn saith that he was personally acquainted with Jeremiah Jones during the Revolutionary Struggle for Independence and that he served as a private Soldier during the same when ever called on in General Marion's Camps under the command of Captain Andrew DuBose & the said Peter DuBose as first Lieutenant & others -- officers of the war.

Sworn to before me this third Day of November 1828.
