[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]



State of South Carolina District of Charleston: On this 7th day of November 1842 personally appeared before me James Lynah planter age 48 years a resident of Charleston SC who being duly sworn according to law, Doth on his Oath make the following declaration, on his own behalf, and on by half of the other children of Surgeon Edward Lynah deceased, in order to be entitled to the benefit of the provisions of the act of Congress of the 7 June 1832, and all other acts of Congress made in relation to this case, That, Deponents father the said Edward Lynah entered the Army in the year 1776 or immediately after the commencement of the revolutionary war, as a Surgeon in Colonel D. Horry's [Daniel Horry's] Regiment of Cavalry South Carolina line. Deponent has reason to believe that, said Edward Lynah served with said Regiment in various places in South Carolina and Georgia two years, Deponent saith his grandfather James Lynah served also in said Regiment at same time, and as a Surgeon said James Lynah died in the year 1809. -- Deponent saith his father the aforesaid Surgeon Edward Lynah died on the 27th day of August 1834 near the City of Charleston. Deponent saith that the said Edward Lynah never to his knowledge received any pension from the State war General government in consequence of the above services.

State of South Carolina District of Charleston: On this 11th day of November 1842 personally appeared before me James Mathews, pastor [could be "factor"], aged 69 about, a resident of the City of Charleston who being duly sworn according to law Depose that he was acquainted with Doctor Edward Lynah deceased, that, he has heard and believes that said Edward served as a Surgeon in Colonel D. Horry's Regiment of cavalry South Carolina line during the war of the revolution, that said Edward died on the 27th day of August 1834, leaving five children, to wit: James Lynah, Edward Thomas Lynah, Mary A., now Mrs. Faber, Ellen Monica, now Mrs. Herseant, and Elisabeth, now Mrs. Hamilton.

That said above named children are of full age, and are the only heirs at law of said Edward known to Deponent or believed to be in existence.



I do hereby certify that subsistence in the Army of the revolution meant stores in addition to rations of bread & meat, such as tea or coffee, and sugar, wine, vinegar, pepper or money in lieu thereof. These stores were given only to officers, or invalids. Pay varied according to laws & arrangements of Congress. A surgeon's pay was \$60 per month a surgeon's mate \$40 -- each a ration for a servant.

I hereby certify that the above named William Read is a Revolutionary pensioner on the South Carolina Roll, as a surgeon & Physician at the rate of \$40 per month, that the above appears to be his usual signature, and that the venerable Gentlemen is universally esteemed in this City.

[Veteran was pensioned at the rate of \$240 per annum for 12 months service as a surgeon in South Carolina.]
