[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## State of South Carolina Union District} to wit

On this the 10th day of November in the year of our Lord 1832 personally appeared in open Court before John J Pratt one of the Judges of the Court of Ordinary of the said State now sitting James Hollis a resident of Union District in the State aforesaid aged seventy five years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers and served as herein stated.

This applicant was born according to the information derived from his parents (having no record of his age himself) on the nineteenth day of August in the year A.D. 1757 in the parish of Wanworth Surry County [sic, Wandsworth, Surrey County, England] on the River Thames about five miles above the City of London in England. He passed over to Charleston with a portion of the sixty third Regiment of the British Army & there joined the troops under the command of Lord Rawdon, marched with him to the relief of Ninety Six and was also at the Battle of Eutaw [Eutaw Springs, September 8, 1781]. After this he was stationed at Hadrels point [Haddrell's Point] in the harbour of Charleston where he deserted the British Army and took protection with General Marion [Francis Marion] at that time encamped at the high hills of Santee in South Carolina. From this place he proceeded to Georgetown, thence to Wilmington in North Carolina and finally to Duplin County in North Carolina where he volunteered or enlisted as a fifer in a company of North Carolina State Troops under the command of Captain Rhodes [Joseph Thomas Rhodes]. This was about eighteen months before the peace. From Duplin County in North Carolina this applicant proceed [proceeded] with Captain Rhodes' Company to Edisto in South Carolina where his Company was attached to or joined the Regiment of North Carolina Troops under the command of Colonel Litle [sic, Archibald Lytle] at that time encamped on the Edisto with the main Army of General Green [sic, Nathanael Greene]. He proceed [proceeded] in the same company and Regiment with General Green across Ashley River and was stationed on James Island – near Charleston, when the city was evacuated [December 1782] by the British troops. After this event the General's headquarters was removed to the City, but the troops to which this applicant was attached still remained on James Island, until sometime after the news of peace, when this applicant under the command of Captain Hall [Clement Hall, Jr.?] of North Carolina was marched back to Wilmington in North Carolina and discharged late in the fall after

the peace. He received a written discharge signed by Colonel Litle the commander of his Regiment which considering of no value he has long since lost. He settled in Catham [sic, Chatham?] County in North Carolina where he lived for about three years after the war, when he removed to the State and District aforesaid where he has lived ever since.

This applicant has no documentary evidence nor does he know of any of his former acquaintances in the Army in this part of the country who can testify as to his services as above set forth. But he refers to the Reverend Thomas Ray and John Norman Esquire as persons to whom he has been long known in his present neighborhood and who can testify as to his character for veracity and their belief of his services as a soldier of the revolution.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State.

Rhodes company of the 10th Regiment enlisted \_\_ that he was mustered in December 1782 and that nothing more is said of him on said rolls.

[Veteran was pensioned at the rate of \$66 per annum commencing March 4th, 1831, for 18 months service as a musician in the North Carolina Continental line.]
