Pension application of James Cuningham (Cunningham) S21723 fn12SC

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of South Carolina Lancaster District: On this 20th day of November A.D. 1833 personally appeared in open Court before the Honorable Josiah J Evans Judge presiding in the Court of Common Pleas now sitting James Cunningham a resident of Kershaw District in the State aforesaid aged seventy-one years who being first duly sworn according to law, doth on his oath make the following Declaration in order to obtain the benefit of the Act of Congress passed 7th of June 1832. That he was drafted as a private in the South Carolina militia on or about the first of October 1781 & served until the first of January 1782 – whilst in service he was under the command of Captain Ben Haile of Colonel John Marshall's Regiment raised in the neighborhood of Lynches Creek Kershaw District by order of General, Sumter. In this Draft – he was confined to the upper District of South Carolina – was in no engagement with the enemy & was verbally discharged.

That he was again Drafted in the South Carolina militia as a private on or about the 10th of March 1782 to go on what was called the Four hole expedition; he served in this Draft six weeks, and in service he was under the command of Captain Josiah Evans of Colonel Marshall's Regiment under the orders of General Henderson – in this tour he was confined to the lower part of the State of South Carolina –

He was again drafted on the 15th of October 1782 and served for the term of two months in the neighborhood of Orangeburg South Carolina whilst in service he was under the command of Captain Josiah Evans of Colonel Marshall's Regiment & under the orders of General Thomas Sumter a part of the time & part of the time under the orders of General F. Marion was in no Battle – verbally discharged.

That he makes this Declaration in the District of Lancaster, the Court House of said District being more convenient to him than that of his own (Kershaw) District –

That he don't know of any of his camp associates who could prove his service now alive.

That he served with an embodied Corps called into service by competent authority: — That he was either in the field or in garrison: — and that the time during which the services were performed, he was not employed in any civil pursuit.

That by reason of old age and the consequent loss of memory he cannot swear positively as to the precise day of each draft –, he entered into, & was discharged from, service; but according to the best of his recollection, each draft took place about the time above specified, and he served not less than the periods mentioned in the foregoing Declaration.

That he hereby relinquishes every claim whatsoever to a pension or annuity except the present, and declares that his name is not on the pension Bill of the agency of any State.

To the Questions proposed he answers as follows Answer 1st – in Ireland October 1762.

Answer 2nd. I have no record of my age.

Answer 3. In Kershaw District South Carolina, where I was living when called into service, where I have lived since & where I now live.

Answer 4th. I was drafted.

Answer 5th. Generals Sumter, Marion, Colonel Marshall

Answer 6th. I received both a written & verbal discharge.

Answer 7th. I name the Reverend Mr. Willie & George Perry, William

Sworn to this 20 November 1833
