[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky Campbell County SS

On this 27 day of May in the year 1833 personally appeared in open court before the justices of the County Court of Campbell County now sitting – being a court of record Jonathan Huling a resident of the said County of Campbell and State aforesaid aged seventy-two years past, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers and served as herein stated – That in the year 1781 he entered the company of militia of Riflemen in the County of Rockingham in the State of Virginia under Robert Cravens [probably Robert Craven] who was his Captain, William Smith was his first Lieutenant – James Dever was his 2nd Lieutenant – David Raleston [sic, David Ralston?] was his Ensign – he joined the main Army under General Stephens [Edward Stevens], at a place called Hillsborough in North Carolina, and marched from thence to Charlotte Court house in North Carolina & from thence to the Cheraw Hills on the Pe. de. [Pedee] River & remained there during the winter and in the spring marched from thence to Island Ford on the Adkin [Yadkin] River, where they were attacked by Cornwallis during the night – and it was there said we had six men killed and forty of the enemy – on the same day General Stephens had crossed with the main Army over the Adkin River and encamped on the bank. Cornwallis moved up the said River on the opposite side from where Stephens was - General Stephens retreated to Guilford Court house - and he was discharged near Guilford Court house. That he knew General Stephens, he knew Captain Richard Yancey, Major Ben. Porter of the regular Army he also knew General Greene whom he saw at the Adkin River – He remembers a man whose name was Triplett – he thinks he was an aide to General Stephens – Colonel Morgan passed by while he was at the Adkin River – that he has no documentary evidence of his service, and he knows of no person by whom he can prove the fact of this service – That he is personally acquainted with General James Taylor, Colonel Richard M Johnson, Colonel John McKinney, Richard Southgate and many others who can testify as to his character for veracity and their belief of his services as a soldier of the revolution – that he continued in service about six months under one engagement. He hereby relinquishes every claim whatever to a pension or annuity except the present & declares that his name is not on the pension roll of the agency of any State.

Sworn to & subscribed the day & year aforesaid.
