## Pension application of James Murphey (Murphy) S25317 Transcribed by Will Graves

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

## State of Virginia Wythe County, to wit

On this 24<sup>th</sup> day of January 1823 personally appeared before me John Johnston a Magistrate of the County aforesaid, James Murphey and made oath that he served as a private in the company commanded by Captain Woodson [Robert Woodson] of the Regiment commanded by Colonel Buford [Abraham Buford] during the Revolutionary War at the time he was disabled and that he was placed on the pension Roll of Virginia at the rate of \$5 per month originally, which has since been increased to \$8 per month and that he has never received a certificate to that affect from the War Department.

The printed list of Wythe County Virginia Invalid pensioners shows James Murphy, Pvt. 6<sup>th</sup> Virginia Regiment rate \$60 per annum, placed him pension roll January 3, 1786, pension commence January one 1786 under Act June 7, 1785.

Increased to \$96 per annum, from April 24, 1816, Act April 24, 1816.

[Veteran was pensioned at the rate of \$8 per month for service as a private in the Virginia Continental line.]

I do, with the advice of Council, hereby certify that James Murphy of Montgomery County, aged 32 years old late a Private in the 6<sup>th</sup> Virginia Regiment, appears to have been disabled in such a manner while in the Service of the Continent, as to enable him to the Sum of Eighteen Pounds yearly; which allowance is accordingly made him, to commence from the first day of January 1786.
