[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Sir

I understand that a pension was paid to John O'Hara of Maryland, as a Soldier (a Sergeant perhaps) of the Virginia line, who was afterwards in Wayne's Command and wounded at Stoney Point [70 Point July 16, 1779]. This pension was continued until 1813 or 14 when he died. I wish to know whether the evidence in his case is sufficient to enable his widow, who married in 1786 to a pension under the act of last Session. Will you oblige me by examining, and informing me what evidence exists in this Case?

State of Maryland Anne Arundel County SS

On this 2nd day of May in the year of our Lord 1839 personally appeared before me Chief Judge of the Orphans Court of the above named County, Susan O'Hara, a resident of the aforesaid County and State of Maryland aged eighty-two years who being first duly sworn according to law, doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed the 17th day of July 1838 Entitled an act granting half pay and pensions to certain Widows, that she is a widow of John O'Hara who

enlisted in May 1776 and discharged in August 1779 in the Second Maryland Line Continental Troops, that he the said John O'Hara received a wound at Stony Point Battle in his right foot which caused him to be disabled through life. That he was under Lieutenant John Gassaway of Annapolis and Major Osborne Williams of the same Maryland Continental Line, and she further declares that she was married to the said John O'Hara the 3rd day of July 1790 by Parson Claggett of Prince George's County State of Maryland in a village called Nottingham in the said County, and any evidence the Department wants of my marriage or standing in society I will furnish at any time they may think proper, my Husband John O'Hara has been a teacher of an English School ever since the revolutionary war owing to the wound he received at stony point and the said John O'Hara died January the 4th 1814 in the City of Annapolis A. A. County Maryland, and the said John O'Hara was attached to the Second Maryland Regiment, and was discharged in 79 and the said Susan O'Hara was born October the 3rd 1757 which ages her eighty-two from record she has in her possession at the present time. She the said Susan O'Hara had two sons William and John and William has been County Collector and High Sheriff of the County and also one of the Commissioners of the County and likewise a Trustee to the Alms House and Chief Judge of the first District Court of the same County – and the said Susan O'Hara has remained a widow since the death of the said John O'Hara to the present time and which will more fully appear by reference to prove here annexed.
