[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

The State of Ohio Butler County: SS: Court of Common Pleas of the Term of July 1832 –

On this day to wit the 31<sup>st</sup> day of July 1832 personally appeared in open court before the Honorable the Judges of the Court of Common Pleas now sitting within and for the County of Butler in the State of Ohio, Isaac Hull a resident of the County of Butler in the State of Ohio aged about seventy-two years, who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the benefit of the Act of Congress passed June 7<sup>th</sup> 1832 –

That he entered the service of the United States under the following named officers and served as herein stated – he entered the service as a volunteer under Captain William Bruce in the County of Washington in the State of Pennsylvania in the year A.D. 1781, he thinks in the month of July in that year at any rate it was about harvest time – he was attached under Captain Bruce to a Regiment commanded by General Clark [George Rogers Clark] – none better possibly by the title Colonel Clark – said Regiment was more immediately under the [indecipherable word] and Colonel Crockett [probably Joseph Crockett] – he states that the Company to which applicant was attached was at that time intended to be marched to Detroit against the Indians – but their direction was afterwards changed and they left Washington County immediately for the Falls of Ohio to fight the Indians – They stopped a short time, however, when on their way to the Falls, at Pittsburgh Pennsylvania and also at Wheeling, Virginia. They did not stay long however at either of those points – several of General Clark's men had deserted – and they then proceeded to the Falls of Ohio at which place they halted – and he was marched to various points in and about the country surrounding the Falls, until sometime in the winter following. Applicant was in one very severe battle at or about the rolling Fork as he thinks it was in Kentucky, this place was about two days march from the Falls. The circumstances that led to the battle, were these, – the Lite horse had been sent out to fetch in some individuals from an adjoining Garrison, and were attacked by the Indians on their return – and the most of them were killed – Applicant was then marched out under Major Wales immediately after this news was received against said Indians, and they succeeded in driving the Indians, and then succeeded in bringing in the remainder of the party then at said Garrison – the name of which applicant cannot now recollect – this skirmish took place sometime during the fall, following the commencement of applicant's services aforesaid – he was kept in the service as aforesaid until sometime during the winter following when he was discharged by Captain Bruce and suffered to return home; Applicant thinks that it was in December of 1781, that he was discharged as aforesaid – he received no written discharge; neither has he ever received any compensation for his services aforesaid.

Applicant on a second reflection thinks that it was later than December when he was discharged, he volunteered as aforesaid for a nine months tour, and he served his time out fully, before he was discharged as aforesaid. Applicant believes that he was born in the year 1760 in the month of August of that year – he has no written Record of his age – he was born in Lancaster County Pennsylvania – he resided in Washington County Pennsylvania when he so as aforesaid entered the service of the United States – he had lived there better than three years previous to his going as a volunteer, as aforesaid. After the revolution Applicant removed near Hagerstown Maryland – he then resided a while about Winchester Virginia – he went back after this to Washington County Pennsylvania and from thence to the County of Butler in the State of Ohio where he now resides, and has resided for the last fourteen years – Applicant states that he has no documentary evidence of his services and that he knows of no person in this Country whose Testimony he can procure who can testify to his services.

Applicant states that he is personally known to Robert B Millikin, Jacob Mitcheler, his Honored Daniel Millikin one of the Judges of Butler Com. pleas court others in his neighborhood and who can testify as he believes to his character for truth and veracity and their belief of his services as a soldier of the Revolution.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any state.
