State of Tennessee Warren County

On this the 3rd day of October personally appeared in open Court before William J Todd, William Majuyer [?] & Aron Higginbotham they being the Justices holding the County Court of Warren County which court is now in session William Bond a resident of the County aforesaid and State aforesaid aged sixty-seven years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June the 7th 1832. That he entered the service of the United States under the following named officers and served as herein stated, to wit

That on the 24th day of July 178_[last digit written over and obliterated] as well as he now recollects he was mustered into service at Hamblin's old store in Surry County North Carolina. He went into the company of Captain Jones – he does not recollect his given name, the Lieutenant of the company was by the name of Reynolds, his given name not recollected the Major who had the command over the Company was by the name of [word written over and obliterated] Hartgroves, the Colonel's name was Elisha or Elijah Isaacks the General was by the name of Rutherford, all of his company were militia men, he volunteered into the service. There was one Harrison [?] who lived in Wilkes County NC who was drafted whose wife was in a state of domestic solicitude and Colonel Benjamin Clinton consented for him to go in Harrison's place, which he did. He was born in Charlotte County State of Virginia and moved from there to Wilkes County in the State of North Carolina, after he was mustered into service he was marched from the old store across the Shallow Ford of the Yadkin River through the Moravian town, from there to Deep River all in NC from there he was [several indecipherable words] after the Tories commanded by Colonel Fannon [sic, David Fanning] and was engaged in a Battle with them on Deep River Colonel Isaacks Regiment was stationed on Deep River for the purpose of keeping the Tories in subjection. He does not recollect the number of Isaacks Regiment. He does not recollect the names of any of the Continental officers except General Rutherford. He was discharged in the Deep River country but does not recollect the County it was done about the last days of April 178_[last digit obliterated] by Captain Jones, his father was drafted into the service his given name was Jesse about the same time applicant was and was mustered into service at the same time and place and served in the same Company, his father was discharged about a month after Cornwallis was taken and applicant not till 2 or 3 months afterwards, perhaps 4 months

after his father was discharged he requested James Gray to get applicant's discharge and take care of it and bring it home. Gray got it what he done with it applicant does not know. Applicant was then in his seventeenth year, he is confident that he served nine months in all. That he is from the 24th of July 1781 till the last days of April 1782. To the Interrogatory where and what year were you born in, he says he was born in Charlotte County State of Virginia on the 24th day of September 1760 [? last 2 digits are unclear]. To that of Have you any record of your age he says he has none. To that of where he lived when called into the service and where he has lived since the revolution, he says he lived in Wilkes County NC and that about 2 years after the revolution he removed to Greene County State of Georgia he lived there about eight years, from there he moved to [indecipherable word] County State of Kentucky in which state he lived about twelve years, from there he moved to Warren County State of Tennessee where he now lives as to the names of the regular officers, Continental and militia regiments he can state nothing more than is stated in the body of his declaration. He was discharged by Captain Jones as above stated. He has no documentary evidence of his service nor does he know of any person living by whom he can prove it. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State. Sworn to and subscribed the day and year aforesaid.
