[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Illinois Fayette County

Be it remembered that on this 4th day of September 1832 personally appeared before the County Commissioners Court of the County of Fayette, now sitting, the same being a Court of Record, John Diamond a resident of the County of Fayette and State of Illinois aged eighty-two years on the 15th of February next, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7, 1832.

That he was born in the County of Derry in Ireland on the 15th day of February 1750, but has no record of his age. That according to the best of his recollection sometime in the year 1775 or 1776, he then living in Camden District in the State of South Carolina, he volunteered as a private under the command of Major Frank Ross [Francis Ross],¹ in Colonel Neal's [sic, Neel's] Regiment of mounted militia -- And then marched to Briar Creek in the State of Georgia, where was a battle with the British & Tories, called the battle of Briar Creek, or Ashe's defeat [March 3, 1779].² He being that day ordered to storm a garrison about ten miles below was not in the battle. Generals Ashe [John Ashe] & Albert [sic, Samuel Elbert] had the command of the American troops. After this defeat, he repaired with Major Ross to Augusta Georgia, where hearing that the Cherokee Indians were about to join the enemy, he marched after said Indians, and came up with them at a River called Rocky Comfort -- And a battle ensued in which Major Ross received a wound, of which he afterwards died in Augusta [Ross died March 31, 1779]. He was then in service about seven weeks. He soon afterwards enlisted in Captain Patton's [Robert Patton's] Company in Colonel afterwards General Sumter's [Thomas Sumter's] Regiment, where he ranged about South Carolina. He was in the service then about six weeks. He was then in Captain Robert Thompson's Company, in the bounds of Colonel Neal's [Andrew Neel's] Regiment, employed as Rangers in said State of South Carolina, and continued with him according to the best of his recollection 6 months or more. He was afterwards a volunteer under General Greene [Nathanael Greene] and guarded the South Carolina Legislature at a town called Jacksonborough, in the forks of Edisto [River] -- at the same time he was with a party that when

out to gather cattle & supplies for the Army. This tour lasted about 5 or 6 weeks -- Afterwards he repaired to Ninety Six, and continued there under General Greene, during the siege of that place, and was with him there about 3 weeks.³ He was also in the battle of Guilford Court House⁴ in North Carolina, under Col. Billy Washington [sic, William Washington].

The deponent says that almost during the whole war he stood as a minute man, & kept a horse ready for service at a moment's call -- that it is impossible to recollect and State all his services -- but this he states, that on account of the unsettled state of the country, & his frequent calls to the service, for 2 years during the time embraced in the above account, he never raised a crop, or stayed with his family a month at a time.

He received several discharges signed by Major Ross & Colonel Washington, but a few years ago, all his papers were destroyed by water, his discharges included.

He states that Robert R. McLaughlin & William Lee D Ewing have for a long time been acquainted with him, and also the Reverend Francis Brown who promised him to attend this court & make the necessary Certificate -- but who was suddenly called from home on account of the death of his brother.

That since the revolutionary war he has lived in the State of Georgia, 25 or 26 years, afterwards in the Cherokee Nation, afterwards in the State of Tennessee about 13 years, and for the last 14 years in this State. He further states that he knows of no one by whom he can prove any of the services aforesaid nor has he any documents to establish any of said facts.

He hereby relinquishes every claim whatever to a pension or annuity, except the present, and declares that his name is not on any pension roll of the Agency of any State.
