[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Alabama, Jackson County

On this 14th day of August A.D. 1832 personally appeared before the Judge of the County Court William Jenkins, a resident of said State and County, and the 71st year of his age, who being first duly sworn according to law, doth on his oath make the following Declaration, in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832.

That he volunteered with Captain Thomas Jenkins and entered the Service of the United States under the following named Officers, Col. William Bratton & Captain Thomas Jenkins, thinks it was in the Spring of 1780, that he volunteered; he then resided in York County South Carolina, the Army embodied on the East side of the Catawba River, from where he lived – And on the first evening after he arrived at the camps he was appointed a Sergeant. In a short time they were informed, that about one hundred & fifty Tories, and about thirty Dragoons of the British Army, had assembled near the residence of Colonel William Bratton, that Colonel Bratton & Captain Jenkins with about 100 men, him being one of that number, Started & traveled all night and about day discovered the main guard & fired upon them who retreated, they advanced to the mouth of a Lane, where an engagement took place with the dragoons, in which one of them, to wit Captain Hook [sic, Christian Huck] was killed,¹ the balance then fled – he sometime after this engagement Joined the Army under the Command of General ~~Rutherford~~ Sumpter [sic, Thomas Sumter], was not engaged in any other battle during that campaign. After he had served something like two or three months, his uncle Thomas Jenkins (who was his Captain), himself, John Henry, James Meeks & Ezekiel Eandloe [sic, Enloe?], went back to the neighborhood in which they lived, (apprehending no immediate danger) to ascertain how many they could get to Join the Army, & stayed all night, and about day light they were attacked by about twenty-five Tories – who took them prisoners, and conveyed them to ninety six Jail, then in the possession of the British – he was then confined in close Jail for about five Weeks – he was in delicate health & remained at home for some time now not recollected – but during that time, he was occasionally engaged with other Whigs, against scouting parties of Tories. He was then appointed Lieutenant, and procured a Company of men, there being no Captain, he marched them to Orangeburg, and served two three-months tours as a Lieutenant. He was then promoted to a Captain, and served as Captain one three-months tour, still remaining at Orangeburg from there he went home. And was engaged in scouting parties after the Tories – but did not enter the Regular Army anymore. His commission as Lieutenant is hereto annexed, but his Commission as Captain, has been, & now is lost. He believes he served as a Sergeant seven months not less

than six, he never received any discharge. He hereby relinquishes every claim whatever, to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any State.

Questions by the Court

1st: Where and in what year were you born?

Answer: I was born in Maryland on Clear Creek but do not know what County – I was born in the year 1762 --

2nd Have you any record of you age and if so, where is it?

I have a record of my age, which I took from my Father's record.

3rd Where were you living when called into service? Where have you lived since the Revolutionary War and where do you now live?

I was living in South Carolina York County – when called into service, I have lived since the Revolution in the York, until the War was over, & about 10 years afterwards, In Pendleton District S. C. about 20 years, In Rutherford County Tennessee, about one year & in Franklin County Tennessee, something like seven or eight years. I then came to Jackson County Alabama, where I have lived ever since.

4th How were you called into service; were you drafted; did you volunteer, or were you a substitute and if so for whom did you substitute?

I was a volunteer.

[5th State the names of some of the Regular Officers who were with the troops where you served, such Continental and Militia Regiments as you can recollect and the general circumstances of your service.]

The names of the Officers under whom I served & the Circumstances of my services are stated correctly in the above Declaration, as well as I can now recollect.

6th Did you ever receive a commission; and if so by whom was it signed; and what has become of it?

I received a Lieutenant's Commission which is hereto annexed, and also a Captain's Commission which was signed by Governor Rutledge [John Rutledge], I believe, though I am not certain – I have lost it.

7th State the names of persons to whom you are known in your present neighborhood, and who can testify to your character for veracity and good behavior and your services as a Soldier of the Revolution.

I am known by James Doren, Sr. & James Doren, Jr., Thomas Russell, James Russell, James Soller [?], James Kisier, Jr., Will D. Gains & others all of whom can testify to my character for veracity &c.f

[James and Thomas Russell & Silas Parsons gave the standard supporting affidavits.]

[p 15: On January 24, 1838 in Pike County Arkansas, the veteran applied for the transfer of his pension benefit to the Arkansas agency having moved there to spend the remaining days of his life with his son (not named).]

[file (p. 18 of Fold3.com version) contains a printed form of a commission with the blanks filled in to appoint Jenkins as a lieutenant in the SC militia—signed by J. Rutledge [John Rutledge,

Governor of the State of South Carolina].]

[Veteran was pensioned at the rate of \$170 per annum commencing March 4th, 1831, for service for 6 months as a Sergeant, for 6 months as a Lieutenant, and for 3 months as a Captain in the South Carolina militia.]




