On this the third day of September Eighteen hundred and thirty two Personally appeared in Open Court before Ezekiel Buffington, Joseph Dunagan & Thomas J Tate Judges of the Superior Court of Said County sitting as Judges of the Court of Ordinary now sitting William Fleming, a resident of Hall County State of Georgia aged seventy one years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed the 7th day of June 1832.

That he entered the Service of the United States under the following named officers and served as herein stated.

That on the 2nd day of March 1779 he was drafted into the Service under Lieutenant Elijah Fleming & Major Ross [probably Francis Ross] and was at Ashe's [John Ashe's] defeat at a place called Brier [Briar] Creek bridge [March 3, 1779], returned home after a tour of two

months in the month of July the same year. Was drafted again under Capt. Saddler [Richard Sadler] & Col. Watson [Samuel Watson]. Was one of the picket guards at the Battle of Stono [June 20, 1779] and not being called in was not in the engagement. Served two months was discharged & went home. Went to Cumberland River in the (State (of now) Tennessee) to a place called the French Lick there volunteered under Capt James Leeper and served eight months where we were compelled to get our subsistence from the Woods at the end of said time returned home. Volunteered again under Captain Hannah, Major Moore, Col Bratton / William Bratton], Lieut. Col Hathorn [James Hawthorne] and Genl Sumpter [Thomas Sumter]. Served twenty three months and 18 days in the years of 1780, '81 & '82. Was in the following engagements to wit on the Wateree [River] in Camden District South Carolina where we took Col Philips then marched to a place called Friday's Fort on the Congaree [River] in South Carolina remained there until Genl Lee [Col Henry "Light Horse Harry" Lee] came marched up from Thompson's Fort and took Fort Friday after firing one or two rounds. We then marched to Bickum Church [Biggin Church] then marched home and was discharged and quit the service in the Year 1782. That he has no documentary evidence; that he resided in Rutherford County State of North Carolina when he entered the service. He freely relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension role of the agency of any state.

Amendment to the Declaration of William Flemming [sic]

Georgia Hall County:

Personally appeared before me an acting Justice of the Peace in & for said County William Flemming [sic] who being duly sworn deposeth and saith that by reason of old age and the consequent loss of memory he cannot swear positively as to the precise length of Service; but according to the best of his recollection he Served not less than the periods mentioned below and in the following grades,

On the Second day of March 1779 I was drafted into Service as a private militia man under Lieut. Elijah Flemming and attached to Major Ross' Battalion & Col. Neal's [probably Thomas Neel's] Regiment and marched to a place called Briar Creek Bridge at which place Colonel Nash [sic, John Ashe] was defeated by the enemy. I was not in the engagement Major Ross with Sixty of his men having been that morning ordered out to ascertain the situation & strength of the enemy who we had learned were in the neighborhood, but to our surprise when we returned to the Camp in the evening the British were in possession and took thirty of our men before we were apprised of the defeat of our troops, the remainder of our men retreated and sometime in the night came up with a part of Col. Nash's men who had encamped on the South Side of Savannah River. On the next morning we started for the headquarters of General Williams [probably Andrew Williamson] near the City of Augusta (or where it now stands). I remained at this place two or three weeks and was discharged having served Two months.

Some time in the month of July [sic, probably June] in the Same year I was drafted again for Two months as a private militia man under Capt. Saddler [Richard Sadler] and attached to Lt. Col. Watson's [Samuel Watson's] Regiment and marched to Stono a place on Stono River had been there three or four days before the battle was fought at that place. I was on the picket guard which was not called in and consequently was not in the engagement. After the engagement was over I was marched up the River two days march and encamped where I remained until my term of Service ended. I was discharged verbally & returned home.

Some time in the month of October in the same year I volunteered as a private militia man under Capt. Leeper and marched to Cumberland in the State of Tennessee to guard the Settlements against the Indians and was Stationed at a place called the French Lick (the place where Nashville now stands). Shortly after getting there Capt. Leeper was wounded in a skirmish with the Indians and was succeeded by Capt. Drake. We had several skirmishes with the Indians during this Campaign in which I served eight months but being informed that such Service is not recognized as military Service. I hereby relinquish all claim to said eight months service.

Sometime in the month of February 1781 I volunteered as a private militia man under Capt. Hannah who was ordered with his company to march to where a parcel of Tories had embodied on the Wateree Creek. We were attached to Major Moore's Regiment in this expedition the above named place is situated in Camden District South Carolina. We took Col. Phillips and a considerable number of the Tories under him and marched them to Block=house

on Allison's Creek. After remaining there four or five days I was discharged having served Thirty days.

In a short time after getting home I was drafted into Capt. Hannah's Company as a private militia man for two months and attached to Col. Bratton's [William Bratton's] Regiment and marched to Friday's Fort [Fort Granby, May 14-15, 1781] the which was in the possession of the enemy. We besieged the Fort and remained there until the enemy surrendered. Shortly after which I was discharged & returned home.

In about 2 months I was again drafted into Capt. Black's Company as a private militia man and attached to Col. Bratton's Regiment and marched to Bickum Church [Biggin Church, July 16, 1781] which was in the possession of the enemy – who set fire to the Church and retreated at our approach. We then marched to General Sumter's plantation on the Santee River where we remained until my term of Service (which was two months) expired being discharged I returned home.

Capt. Black then received orders from Col. Bratton to keep his men in readiness to march at a minutes warning and I was kept in this situation at least 18 months sometimes in pursuit of the Tories and at other times watching their movements and generally guarding the Settlements for which 18 months Service I hereby relinquish all claim being informed that it is not considered military Service.

But for the foregoing nine months Service done under Competent Authority I claim a pension.
