[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Commonwealth of Massachusetts

Be it remembered, That I Nicholas Bartlett, Aged 69 of Marblehead in the County of Essex in the Commonwealth aforesaid, doth make upon oath the following Declaration, to wit,

That I served in the naval service of the United States in the American Revolutionary war -- that I entered May 1st 1776 as first Lieutenant on board the United States Schooner of war *Hancock* -- Samuel Tucker, Commander and was employed cruising against the Enemy until February 15, 1777 -- then left the said schooner by request of the Board of war -- did take charge and command of the Brig *Penet* -- in the service of Government to go to France for military stores proceeded on this voyage and returned to Boston, July 1777 with a cargo of powder -- arms, clothing &c -- for the Army of the United States.

I further testify and declare -- That being in Holland, I entered June 6th 1780, a Lieutenant under Commodore Gillon [Alexander Gillon]¹ in the Frigate *South Carolina*² -- in the Naval Service, United States and was employed cruising against the Enemy until September 27 A.D. 1781 -- was then honorably discharged.

That the Declarant is infirm; that from his reduced circumstances in life he is now in need of assistance from his country for support; and that he hereby relinquishes his claim to every pension heretofore allowed him by the laws of the United States.

Foote: 112-116, 119, 120, SchV:55, M:274, privateer man of war of 40 guns, 1355 tons, manned by 540 men, which left the Texel (the Netherlands) on 25 August 1781, with SC Navy Commodore Alexander Gillon in command. This vessel was the property of France, originally the *Indien*, built in Holland, loaned to the State of South Carolina for 3 years for privateering. It took part in the Spanish/American capture of Nassau in 1782, under Capt. John Joyner. The ship was taken by the British in Sept. 1782, and crew sent to prison in New York. One of its prizes was taken Sep 1781 and one of its prize crew sent to Mill Prison. (Clark: I:138 shows her captured 19 Dec 1782, by the British *Astrea, Diomeda, Quebec*. The ship is said to have arrived in New York on 24 Dec.) Ford1782:309, 632, 703, Ford1784:332. JA6:295, 9:491. CTN: 58. CTP: 123. I, Robert Pierce of Marblehead in the County of Essex, in the Commonwealth of Massachusetts, Sail Maker do on solemn oath testify and depose, as follows: --

I well know Capt. Nicholas Bartlett, who subscribed the annexed Declaration, I well know that he entered the service of the U. States in the American Revolutionary War, that on the first of May 1776 he entered as first Lieutenant on board the Continental Schooner of War Hancock, Samuel Tucker Commander, and served on board said Schooner until the 15th day of February 1777, when he was ordered by the Board of War to take the charge of the US Brig Penet, and that he went to France and procured a quantity of Military Stores & returned to Boston in July 1777 with a cargo of Powder, Arms, clothing &c for the Army, and I was myself in the service and knew him at the time & his declaration is true.
