[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky [Nelson County]

On this 29th day of March 1819 Before me the Subscriber Judge of the 5th Judicial district of Kentucky & sole Judge of the Nelson Circuit Court personally appeared Eppa Hubbard age sixty years Resident in said County who being by me first duly sworn according to law doth on his oath make the following Declaration

That he the said Eppa Hubbard enlisted for the Term of two years in the month of February 1776 in the company commanded by Captain George Slaughter of the 8th Virginia Regiment commanded by Colonel Muhlenberg [Peter Muhlenberg] & served as a Sergeant until about the 25th of December 1777 when he Reenlisted for the Term of three years in Captain Nicholas Moore's Company of the 4th Regiment of Light dragoons commanded by Colonel Stephen Moylan and others that he served as a Sergeant in the said Regiment until the month of December 1780 when he was regularly discharged from the Service at Lancaster in the State of Pennsylvania, that he was in Battle of Monmouth [June 28, 1778]. That he is in reduced Circumstances & Stands in need of the assistance of his country for support & has no other evidence now in his power of his said services.

Sworn to & declared before me the day & year aforesaid.

James Brooks a reputable witness this first day of January 1820 personally came before me & declared under oath that he was acquainted with the said Eppa Hubbard during the revolutionary War knows that he enlisted as stated in the preceding declaration & saw him in the service in 1777 & does believe that he did serve for the full term of his enlistment. Eppa Hubbard a pensioner of the United States by Certificate dated the 14th day of March 1820 at the Rate of \$8 per month came personally into the Court being a Court of Record and delivered a Schedule of his Estate which the Court valued at \$85 and to which Hubbard made oath agreeably to law. Whereupon it is ordered that the said schedule & oath the recorded and Certified to wit

"On this 6th day of November 1821 personally appeared in open Court being a Court of record for the County of Bullitt in the State of Kentucky, a Resident of said County aged sixty-three years who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the provision made by the Acts of Congress of the 18th March 1818

and the 1st May 1820. That he the Eppa Hubbard served in the Revolutionary War as follows. He in the early part of February 1776 enlisted in Captain George Slaughter's Company of the 8th Virginia Regiment commanded by Colonel Peter Muhlenberg on Continental Establishment for two years. That he would was on the 29th of June [1776] in South Carolina in the Battle of Sullivan's Island. On the 11th September [1777] at the Battle of Brandywine – On the 4th of October [1777] at the Battle of German Town [Germantown] and on the 24th of December 1777, he was discharged at Valley Forge. And on the same day reenlisted in the 4th Regiment of Light Dragoons commanded by Colonel Stephen Moylan and continued in said Regiment till late in December 1780 when the Regiment was sent into winter quarters at Lancaster in Pennsylvania where he received his final discharge. The number of his pension is 16560

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled “an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war” passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed viz.

The Declarant has no mechanical Occupation. He has no family but has for 3 years past resided with his son. By age & infirmity he is unable to Labor for his support.

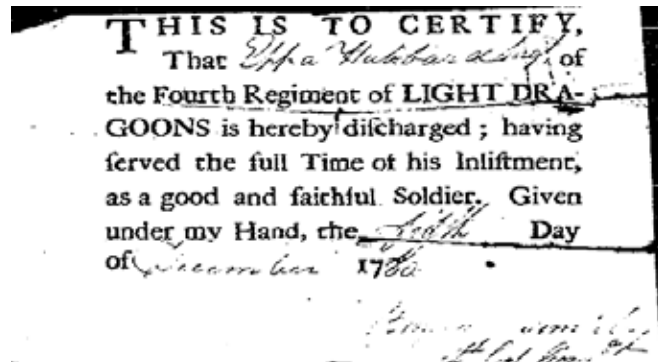
[Veteran was pensioned at the rate of \$8 per month commencing March 27, 1819, for service as a Sergeant in the Virginia Continental line.]
