Pension Application of William Price S35589

Transcribed and annotated by C. Leon Harris

Scott County [KY] Sct

On the 14th of November 1829 personally appeared before the subscriber a Justice of the Court for said County it being a Court of Record for said County William Price Sen'r aged about sixty seven who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provisions made by the Acts of Congress of the 18th March 1818 and the first May 1820

That in the month of March 1781 he was enrolled and Seized [sized?] in the Continental establishment and registered in Fredericksburg Virginia, and was then marched to Richmond in Virginia under the Command of Col Henry Towles in Capt Barbees [Thomas Barbee's] Company. He was then placed under the command of General Stuben [sic: Steuben] until after the Seige of York [19 Oct 1781]. then he was placed under the command of Col. Febriger [sic: Christian Febiger] who after the end of the War discharged him at the Cumberland Old Courthouse, and poor I feel it due to myself to ask the same debt of gratitude awarded to others for similar Services. and in pursuance of the Act of the 1st May 1820 I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain person engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed. that his Schedule of property hereunto annexed is one hors worth \$15. 6 Cows 2 Heifers and 2 Calves worth 46\$. 148 acres of land third rate worth 444\$. 14 head of Hogs worth \$30. and that he owns no other property and there has been no change in his property since the passage of the above named Act of Congress. He states that he was a farmer by profession but from age and debility he is unable to peruse it. William Price Sen'r

This day John Hughs of said County appear'd before me a Justice of the Peace for the county aforesaid and made Oath that he is well acquainted with Wm Price sen'r now a Resident of scott cty and state afforesaid but who formerly lived in Stafford county and state of Virginia that this affiant well remembers said William Price was a private soldier in the contintal army he was sized Enrolled and regersted in Fredericksburg Virginia and then he was marched to richmond in Virginia under the command of Col Henry Toles in capt Barbes Company he was then Commanded by Gen'l Stuband untill after the seige of york then he was under the comand of Col Febeger who after the end of the war Discharged him with honour at cumberland Old Court house the deponent will remembers that said Wm Price Joined the army in March 1781 that he was a sagent at the same time and in the same copany with him given under my hand this 14th day of April 1828

NOTES:

A size roll of noncommissioned officers and privates taken at Carter's Ferry at present Cartersville in Cumberland County lists the following William Price: age 20/ height 5' 5"/ brown hair/ grey eyes/ fresh complexion/ shoemaker/ born in King George County/ residing in Stafford County where he was drafted 21 Mar 1781 for 18 months.

A document in the file states that Price's property was on Eagle Creek.
