[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky Sct.

On the 13th day of July 1818 before me the undersigned one of the Circuit Judges for the Commonwealth aforesaid personally appeared Jesse Rose aged about 68 years resident in Harrison County in said State who being by me first duly sworn according to law doth make the following declaration in order to obtain the provision made by the act of Congress entitled "an act to provide for certain persons engaged in the land & naval service of the United States in the revolutionary war." That he enlisted as a private soldier in the State of Virginia in the company commanded by Captain Shelton [probably Captain John Chilton] in the year 1777 or thereabouts. That he was afterwards transferred to Captain Payton's [probably Captain John Peyton's] company & continued to serve in that company as a private soldier until sometime after the expiration of the term for which he enlisted which was three years. That Captain Shelton's company – Captain Payton's Company belonged to the 3rd Virginia Regiment until a short time after the battle of Germantown [October 4, 1777] when they were transferred to the 2nd Virginia Regiment. That both the 2nd & 3rd Virginia Regiment belonged to the Virginia line of the Continental establishment. That he was at the battle at Monmouth [June 28, 1778] & several small skirmishes. That from his reduced circumstances in life he stands in need of assistance from his Country for support & that he has no other evidence now in his power of his said services.

[Note: a note in the file indicates that the veteran died in 1830. There is no indication that he ever filed the schedule under the provisions of the 1820 act required to continue his pension.]

[Veteran was pensioned at the rate of \$8 per month commencing July 13, 1818, for service as a private for 3 years in the Virginia Continental line.]
