Be it Remembered that this Eleventh day of June in the year of our Lord Christ Eighteen hundred and Eighteen personally appeared before me the undersigned one of the Circuit Judges in and for the said Commonwealth Daniel Barnett and made oath on the Holy Evengalist of Almyty God; That he forted in the service of the United States shortly after the commencement of the Revolutionary War as a Fegular Soldier under Capt William Beatty in Frederick Town in the State of Merryland and served as a Regular Soldier for five years & was Taken prisoner at Gateses defeat [defeat of Gen. Horatio Gates at the Battle of Camden SC, 16 Aug 1780] and Remained a prisoner Tell the End of the War: That he is now about seventy years of age That he is poor and stands in need of the Aid of his Country That he has no other proof in his power of the fact of his being in the war That he has never received any pension for his services That he is a Resident of the State of Kentuckey in the County of Jessamine

Commonwealth of Kentucky 4th Judicial DISTRICT OF Kentucky, SS

On this Seventh day of June 1819, before me, the subscriber, one of the Judges of the Circuit Court of the Commonwealth afores'd for the said district, personally appeared Daniel Barnet aged Seventy years, resident in Kentucky in the said district, who, being by me first duly sworn, according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That he, the said Daniel Barnet enlisted for the term of Three Years on the [blank] day of [blank] in the year Seventeen hundred seventy seven in [blank] in the state of Maryland in the company commanded by Captain Crith [sic: Adam Grosh] of the 7th Regiment commanded by Colonel [John] Gunby in the line of the State of Maryland on the Continental Establishment; that he continued to serve in the said corps, or in the service of the United States, until the year 1780 & then enlisted during the war when he was discharged from service in the state of Maryland, that he was in the battles of Brandywine [11 Sep 1777], German Town [Germantown PA, 4 Oct 1777], Monmouth [sic: Monmouth NJ, 28 Jun 1778] & that he was taken prisoner at Gates's defeat & detained as a prisoner during the war and that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said services.

I further certify that Thomas Richardson a credible witness personally appeared before me and after being duely Sworn according to law declared that, he served with the above named Daniel Barnet in South Carolina, in the regular service of the united states This Deponent did not belong to the same Regt, but the Deponent enlisted in the 4th Regt North Carolina troops in what was usually termed the new levies. the Deponent first served under Capt Robert Moore, in Colo ___ Armstrongs [James Armstrong's] Regt to which Maj Henry Dixon was Majr, and whilst in the service aforesaid he became acquainted with the aforesaid Danial Barret But when or where he enlisted or for how long this Deponent knowes nothing and further says that the said Danial Barnet is poor in low circumstances and needs the aid of his Country

Jessamine Circuit.

On this 18th day of July 1820, personally appeared in open court, being a court of record for said district, and circuit of Jessamine county, Daniel Barnett aged 70 years, resident in Jessamine County in

said district, who being first duly sworn, according to law, doth, on his oath, declare, that he served in the Revolutionary War as follows: that he Enlisted in Frederick Town in Maryland for three years in Capt Crush Company in the 7th Maryland Regt commanded by Genl [William] Smallwood that he served during the war & that his original Declaration 7th June 1819 & No of his Pension certificate 15193

And I do solemnly swear, that I was a resident citizen of the United States, on the 18th day of March, 1818; and that I have not since that time, by gift, sale, or in any manner, disposed of my property, or any part thereof, with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States, in the Revolutionary war," passed on the 18th day of March, 818; and that I have not, nor has any person in trust for me, any property, or securities, contracts, or debts, due to me; nor have I any income other than what is contained in the schedule hereto annexed, and by me subscribed.
