Pension Application of Charles Cullin (Cullen) S35872
Transcribed and annotated by C. Leon Harris.

DISTRICT OF Kentucky, ss.

On this 27th day of May 1818, before me the subscriber, one of the Judges of the Circuit Court of Fayette County for the said district, personally appeared Charles Cullin aged Eighty Two years, resident in Fayette County in the said district, who being by me first duly sworn, according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That he, the said Charles Cullin enlisted in or about 1777 in the state of Virginia in the company commanded by Captain Vivin Minor [sic: Vivion Minor, pension application W23992] of the Virginia line Commanded by Col Harrison for one year and six months in Continenal Establishment; that he continued to serve in the said corps, or in the service of the United States occasionally in the Militia until the year 1780, when he was discharged from service in Bolling Green [sic: Bowling Green] in the state of Virginia, that he was in the battles of [blank] and that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said services.

District of Kentucky ss: Fayette Circuit

On this 23rd day of June 1820, personally appeared, in open court, being a court of Record for the said district and circuit of Fayette County Charles Cullen aged 84 years resident in Fayette County, in said district, who being first duly sworn, according to law, doth, on his oath, declare, that he served in the Revolutionary War as follows: That he enlisted in Caroline county Virginia for eighteen months, in captain Vivin Minors company in Col. Harrison's Regiment that he served the eighteen months in the regular service on the continatal line and was discharged at Hampton in the state of Virginia that his original declaration bears date 17th day of May 1818 and his certificate of pension is number 3540; And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain person engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed.

The within declarant is living on a rented farm for which he pays 30 dollars per annum. He is a cooper by trade but from age and infirmity he is unable to do any thing in the business now – he has a wife living with him, he has had fifteen children but they are all grown and have all left him, the youngest being now in his twenty second year.
