

I have supplied the *omissions* in Mr. Farrell's case. You can certify that Mr. Jno Branham is an acting justice which will dispense with the cost of the seal of the clerk. Yrs. J. J. Johnson

Dear Sir,

I saw your brother yesterday & he was so *obliging* [?] as to amend the declaration but being Court day & having a multiplicity of business, he has *omitted* to mention my reasons for not making application sooner. My reason is this (tho often solicited by my friends to apply) that there were so many applicants for pensions that I could not consent to *become* a charge to my Country whilst I was able to support myself & family, but old age has crept on & made me a solicitor. Should this not answer & there should be any default pray let me know so soon as possible & oblig yrs obt

[p5] The amended declaration of Isaac Farrell states that but little change has taken place in his property since 18th March 1818. I had one mare worth \$20. She died. She had two colts. One died and the other was killed. I had nothing else except hogs & other such property which I made use of yearly for support.

Charles Shepherd, resident of Scott County afsd states that he is well acquainted with the declarant Isaac Farrell being raised in the same neighborhood & were school *mates*. He knows that I Farrell enlisted as stated by him during the war in the Corps stated & did not return until the war ended in 1783.

[p8] State of Kentucky, Fayette County Court October 5th 1827

Isaac Farrell who was a soldier in the Revolutionary War in the service of the United States this day appeared in open court and before the presiding judge thereof subscribed and under oath to his declaration and schedules and William Schooler made oath to the affidavit or deposition both of which are certified by the presiding judge and ordered to be recorded in the words and figures following to wit

State of Kentucky, Fayette Circuit Court of Fayette County set

On this 5th day of October 1827 personally appeared in open court (it being a court of record by law having the power to fine and imprison) for the circuit and County of Fayette, Isaac Farrell resident in said county aged sixty three years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the acts of the 18th March 1818 and the 1st of May 1820 and the 1st March 1820. That he the said Isaac Farrell enlisted for "during the war" on the 1st of April 1781 in the Count of Caroline and State of Virginia in the company commanded by George Buckner in the regiment commanded by Col John Taylor in the Virginia line on the continental establishment. That he continued to serve in said company and regiment until peace in 1783 when he was discharged from said service at Bowling Green Caroline County Virginia. That for his service Virginia granted him a military warrant.

And I do solemnly swear that I was a resident citizen of the United States on the 18th day of March 1818.

[p9] And that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it or to bring myself within the provisions of an act of Congress entitled "an act to provide fro certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that I have not nor has any person in trust for me, any property or securities, contracts, or debts due to me, nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. I live in a house belonging to my son Austin Farrell. I have a few hogs in number 15 worth \$20 and my bedding and clothes. By occupation a school master but from Rheumatic pains & old age, have declined all business except working occasionally on the farm. My family consists of my wife and myself. She is aged sixty four years and hardly able to wait on herself. I am principally supported by my son.

Also personally appeared in open Court William Schooler¹ who made oath that he was a regular Soldier in Captain Minor's Company and in Colonel Taylor's Regiment, which was called the 3rd Virginia Regiment, and well knows, that Isaac Farrell who has deposed to the annexed declaration enlisted and served as a regular Soldier in the Regiment, and for the time specified, in his Declaration, that he is aged 68 years, and resides in the County, and has been well acquainted with the said Farrell, as they were raised in the same neighborhood and school mates.

Isaac Farrell personally appeared before me, a Justice of the peace for said county, and made oath, that in the year 1781 he Enlisted for during the war in Capt Hubbard Taylors Company, of the [blank] Virginia Regiment on the Continental line commanded by Genl. Spotswood [Alexander Spotswood R18089]. That he continued in said service until the close of the war, in 1783 when he was honorably discharged at Bowling Green, Virginia and that through the process of time he has lost his discharge, and cannot produce it to corroborate the above statement. He further declares that he has never received his land Bounty for his services


