Fayette County Sct

This day Robert Green appeared before me a Circuit Judge for the State of Kentucky and made oath that he was a Soldier in the continental service, in the Revolutionary War against Great Britain for the space of three years in the Company commanded by Capt. Gabriel Long [VAS970] of Culpepper [sic: Culpeper] County, Virginia that he enlisted as a Soldier in the County of Culpepper (Va.) under Capt. Long for the space of three years and was honorably discharged by Lieut Philip Slaughter [W29886] of Culpepper County (Va.) that he is [in] the fifty seventh year of his age has always been a Citizen of the U.S. and now resides in Jessamine County and State of Kentucky. That he is poor and by his reduced circumstances and old age stands in need of assistance from his Country for support and begs to be inscribed on the Pension list, as a Soldier of the Revolutionary War and that he has no other Pension


Jessamine County Sct

This day William Lloyd [S36049] appeared before me a Justice of the peace for said County & made oath that he was a soldier in the Continental Service in the Revolution with Robert Green and well knows that he served for a longer time than nine months and that he is poor & stands in need of assistance for support from his County and that the facts set forth in his affidavit are true to the best of his knowledge & belief Given under my hand this 1st day of April 1818. John Downing J.P.

This day James Johnston [sic: James Johnson VAS1229] and George Tannal [sic: George Tennell S37485] personally appeared before me James Robertson a Justice of the pace in and for the County of Garrard and Commonwealth of Kentucky and being first duely Sworen deposed and sayeth; that Robert Green of the County of Jessemen and State of Kentucky enlisted in the service of the united states for and dureing the war and that the said Green did actually serve in Capt James Guns [James Gunn (Gun) BLWt659-300] Company of Dragoons Commanded by Colo White [Anthony Walton White W6477] to the end of the war, and that the said Robert Green was discharged in the year 1783; these deponents farther say that they were personally acquainted with the said Robert Green in the service they beeing part of the same corps and serveing in the same Regiment and they respectivey say that they have reason to beleive said Green has lost his discharge Given under our hands this first day of August 1814

Jessamine County Court

On this 20th day of August 1821 personally appeared in open court being a court of record for the said district and of Jessamine County Robert Green aged seventy years resident in Jessamine in said district, who being first duly sworn, according to law, doth on his oath declare that he served in the revolutionary war as follows: that he Enlisted in Culpepper County and State of Virginia for three years as

a regular Soldier on the Virginia Continental line in the company commanded by Capt. Gabriel Long in the 11th Virginia Reg't. as will more fully appear by his original Declaration bearing date the 6th day of April 1818; and his original Pension Certificate number 297. And I Do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed.

I have no property
I was never married I have no family and live with my Sister in Jessamine County Kentucky and I am by pursuit a farmer and from old age I am not able to work much

Fayette County, Kentucky Sct.}

On this fifteenth day of March 1826, before me the subscriber, a justice of the Peace for the said county of Fayette, personally appeared Robert Green, and inhabitant of Jessamine County and State aforesaid, who on his oath declares that he is the same person who formerly belonged to the company commanded by Captain Gabriel Long, in the regiment commanded by Col. Daniel Morgan, and subsequently in the company commanded by Capt Gun, in the regiment commanded by Col. White in the service of the United States; that his name was placed on the pension roll of the state of Kentucky, that he received a certificate of that fact, under the signature and seal of the Secretary of War; which certificate on or about the 10th day of February 1826 near Niholasville [sic: Nicholasville], Jessamine County and state aforesaid, was destroyed by fire which at the same time consumed his dwelling and its other contents.

State of Kentucky Garrard County Sct

This day George Tennel [two illegible words] appeared before me McAulles Ballenger and made Oath that he was a Sergent in Colo Whites Regiment of horse after Colo Washington was taken Prisoner [William Washington at the battle of Eutaw Springs SC, 8 Sep 1781] and that he was well acquainted with Robert Green who served as a Corporal in the Second troop in said Regiment and was engaged for during the war this deponent is also informed and believes that said Green prior thereto served in Capt Gabriel Longs Company in the Virginia State line on Continental Establishment for more than three years

Given under my hand and seal this 24th day of August 1810.

NOTE: A letter in the file states that Robert Green died on 17 May 1831, and that the last pension payment was paid to his executor, William Green.
