Pension Application of Charles McNabb S36082

Territory of Illinois Ss.

On this Twenty Seventh day of June in the year Eighteen Hundred and Eighteen, before me the Subscriber one of the Judges of the General Court for the said Territory personally appeared Charles McNabb aged Sixty years resident in the said Territory who being by me first duly sworn according to law doth on his oath make the following Declaration in order to obtain the provision made by the late act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the united States in the Revolutionary war:" that he the said Charles McNabb enlisted in the State of Maryland in the company commanded by John Coates Jones [sic: John Courts Jones] of the Seventh Maryland Regiment of the first Maryland Brigade; that he continued to serve in the said corps, or in the service of the United States (from the time of his enlistment in April or May 1778) until he was discharged from service in 1783 at Annapolis in the State of Maryland by General Mordecai Guest [sic: Mordecai Gist] then commanding the Brigade to which this Deponent belonged of which Discharge the said Deponent then received a printed certificate not now in his power or possession that in the year 1781 the said Deponent was appointed by General Washington Forage Master to the Maryland line and received twenty Dollars per month for acting in that capacity until discharged the evidence of which appointment is not now in his power or possession that he the said Deponent was in the battles of Monmouth [28 Jun 1778] & Campden [sic: Battle of Camden SC, 16 Aug 1780] & at the capture of Cornwallis [at orktown VA, 19 Oct 1781] and that he is in reduced circumstances and stands in need of the assistance of his Country for Support; and that he has no other evidence in his power of his said services.

I hereby certify, that it appears from the muster-rolls remaining in the Auditor's Office, that Charles McNabb enlisted as a Sergeant in the Seventh Maryland Regiment, on the Seventh day of June 1778 and was on the 1<sup>st</sup> Nov 1780 present

On this 9<sup>th</sup> day of June 1821 personally appeared in Open Court being a Court of Record for the said County, Charles McNabb aged 64 years resident in the State of Illinois and Randolph County who being first duly Sworn according to law doth on his Oath declare that he served in the Revolutionary War as follows (viz't.) That he entered the service in May 1778 in the 7<sup>th</sup> Regiment Maryland line Commanded by Col. John Gunby, in the Company Commanded by Capt. John C Jones and afterwards served in 3<sup>rd</sup> Regiment Maryland line Commanded by Col. John Stewart in which Regiment he served until the peace of 1783. That he has previously received a pension as per Certificate No. 12, 825. And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of the Act of Congress entitled "An act to provide for certain persons engaged in the Land and Naval service of the United States in the Revolutionary War" passed on the 18<sup>th</sup> of March 1818. That I have not nor has any person in trust for me any property or securities contracts or debts due to me, nor have I any income other that what is contained in the Schedule hereunto annexed and by me subscribed
