Pension Application of Randall Hoskins: S36584

Kentucky Sct

At a County Court begun and held for Washington County at the Courthouse in
Springfield Monday the tenth day of January in the year of our lord one thousand eight
hundred and twenty five and of the Commonwealth the 33rd before the Worshipful
Judges of the said County Court

Randall Hoskins an applicant for a pension under the law of the Congress of the United States this day exhibited in Court his affidavit and a schedule of his property and having made oath to the same the Court value the property therein contained to one hundred and twenty dollars. he also exhibited in Court an affidavit of Richard Mudd which is sworn to by said Mudd, the same are ordered to be record and follow in these words and figures towit.

Original Claim

State of Kentucky Washington County Sct

On this tenth day January 1825 personally appeared in open Court being a Court of Record for the County aforesaid Randal Hoskins aged sixty seven years resident of the County of Washington who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provisions made by the act of Congress of the 18 March 1818 and the 1st of May 1820. that he the said Randal Hoskins enlisted for a term of nine months in the regular service in June 1778 in the State of Maryland in the company commanded by Capt Henry Gathor [Henry Gaither] in the regiment commanded by Colonel [John Eager] Howard in the line of the State of Maryland on the Continental establishment that at the expiration of which time he again enlisted for the Term of three years under said Capt Gathor in the regiment commanded by said Colonel Howard in the same line of service and that he continued in said service until discharged in the State of S Carolina at the Round O on the 18th January 1782. That he was in the battles of Gilford Court house [sic: Guilford Courthouse NC, 15 Mar 1781] Camden [Hobkirk Hill near Camden SC, 25 Apr 1781] Ninety Six [Siege of Ninety-Six SC, 22 May - 19 Jun 1781] Eutaw Springs [8 Sep 1781] and that he has now no other Evidence in his power of his said Service except the affidavit of Richard Mudd hereto annexed. And in pursuance of the act of the 1st May 1820 I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent therby so to diminish it as to bring myself within the provisions of an act of Congress entitled An act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary war passed on the 18th day of March 1818 and that I have not nor has any person in Trust for me any property of Securities contracts or debts due to me or have I any income other than what is contained in the Schedule hereto annexed and by me subscribed.

Two Bay Horses one about 13 years old the other three next Spring four Cattle 23 Hogs 8 Sheep Kitchen furniture Cupboard and chairs Cupboard furniture Farming utensels that he is a farmer and is incapable of doing much labour that has a wife who from her age is also incapable of doing much toward a support and one boy child 8 years old
