Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

The Commonwealth of Kentucky Adair Circuit Sct.

Be it remembered that on the 4th day of October 1819 William Womack [sic] a citizen of Casey County & State aforesaid personally appeared before me Christopher Tompkins Judge in and for the Circuit aforesaid and made oath that in the year 1780 he enlisted as a private soldier in the Continental Establishment in Captain Thomas Bowyer's Company of Major Rodolph's [John Rudolph's?] Battalion Colonel Campbell's Regiment General Greens division Virginia Continental line that he enlisted as aforesaid for and during the war that he served out the full term for which you was enlisted faithfully & honestly that while he was in service he was in the Battles of Camlin [sic, Camden –probably Hobkirk Hill (April 25, 1781)], Utwus [Eutaw Springs (September 8, 1781)] & 96 [Ninety Six (May – June 1781)] and many other skirmishes against the Common Enemy & that he was after the close of the war Honorably Discharged in Charles Town South Carolina which discharge has been destroyed by time and accident he further states that he is now aged and infirm and unable to support by labor, that he is in indigent circumstances and stands in need of his country's aid & claims the same agreeably to an act of Congress of the United States & such [indecipherable word] made & provided.

State of Kentucky Adair County Sct.

At a County Court begun and held for the County of Adair at the Courthouse in Columbia on Monday the 7th day of October 1822

Be it remembered that this day William Warmack personally appeared in open Court being a Court of Record proceeding according to the course of the Common law and by the Statute of Kentucky and made oath in addition to the statements made by him before the Honorable Christopher Tompkins Esqr Circuit Judge of the Commonwealth of Kentucky in Circuit of Adair on the 4th day of October 1819 that in the year 1780 he enlisted as a private in the Continental establishment as stated in said application which he refers to and incorporates the same with this amendment he further states that he is now about 60 years of age that he is a cripple and illy able to labor that he was a resident of the US on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of

Congress entitled an act to provide for certain persons engaged in the land & naval service of the US in the revolutionary war passed on the 18th day of March 1818 that I have not nor has any person in trust for me any property or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me Subscribed he further states that his occupation is a Tiller of the ground. Schedule as followeth viz. he has a wife named Rachel about 44 years of age: she is unhealthy often afflicted with a call for & as he thinks afflicted with the consumption and illy able to labor that he has 11 children 2 of home are married and living with him 8th of home are daughters four of home are nearly grown none of whom are healthy & or unable to support themselves and one of them deranged the others are small and unable to do but little labor, 2 of them nearly deaf he further states that he has one horse beast worth about the sum of \$20 no more, 5 head of cattle worth \$25 & no more, 16 head of hogs worth \$20 [several words too faint to discern] more 3 beds & furniture worth \$30 and no more, small articles of household & kitchen furniture worth \$20 & no more 3 geese worth about 75cents that there is nothing owing to him and that he owes about \$4 he prays for support agreeable to the several acts of Congress upon that subject.

William Solding & Henry Smith personally appeared in open Court and made oath they are acquainted with the above named William Warmack that they believe the above Statements made by him are true, as also the Schedule of Property thereto annexed

This day John Stone & Thomas White also personally appeared in open Court and made oath that they were were acquainted with William Warmack in Virginia, about the year 1780 that they knew he was in the Service of the United States on the Continental Establishment and believe he served the time stated in his application [several words is illegibly faint].

The court further certify that the above named Warmack & witnesses are man of respectability and truth.

[fn p. 9: Marriage bond issued to William Wormack and Andrew Russell on May 14, 1829 to secure the marriage of said Wormack with Mary Judd. The marriage was actually performed February 14, 1830 and is certified by Alexander Sinclair who states "William Womack and Mary Jud February the 14 day 1830" in Adair County Kentucky.]

[Veteran was pensioned at the rate of \$8 per month commencing March 18th, 1824 for service as a private in the Virginia Continental line.]
