## Pension application of Thomas Douglas S37895 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## United States Georgia

Before me John MacPherson Berrien one of the Judges of the Superior Courts of the Law [undeciphered word or words] which said Courts are Courts of Record, personally came and appeared Thomas Douglas aged about fifty three years, who being duly and solemnly sworn on the holy Evangelists of Almighty God did depose and say --

That He this deponent was born in South Carolina according to the best of his knowledge and belief in June 1756. That in the Month of July in the Year 1777, This Deponent Enlisted at Moncks Corner in the State of South Carolina in a Company of Infantry Commanded at that time by Captain Robert Lyall [sic, Robert Lyle of the 3<sup>rd</sup> SC Regiment] and afterwards by Captain Joseph Warley which company belonged to the 3rd Regiment of the South Carolina line on the Continental establishment; commanded by Colonel Thompson [sic, William Thomson] -- That this deponent enlisted as a drummer in said Company, and that the term of his enlistment was for and during the war. That the deponent continued to serve in the said company as a drummer until the fall of Charleston [Charleston South Carolina fell to the British on May 12, 1780], when he was taken prisoner -- and having attempted to escape, was retaken & confined on board a prison ship in Charleston harbor. That after some months the deponent succeeded in making his escape and got to Virginia -- That he returned to South Carolina -- and his own Regiment not having been exchanged, he joined a Regiment of Light cavalry commanded by Colonel Mayham [sic, Hezekiah Maham] with whom he served for twelve months -- at the expiration of which time the Regiment to which he belonged having been discharged, he received notice from Captain Warley to join his Company, which he accordingly did, and served therein until the end of the war & was dismissed in Charleston.

This Deponent moreover saith that he is a citizen of the United States residing in the County of Chatham in the State of Georgia -- and that by reason of his reduced circumstances in life, he is in need of assistance from his Country for support --

This Deponent further saith that he knows Jacob Solter<sup>1</sup> who is now present. That he first knew him at Williams Branch in the State of South Carolina, where the Regiment to which this deponent belonged was stationed, and that the said Solter was at that time a private in Captain Boyakins' [sic, Francis Boykin's] company belonging to the same Regiment -- that this was in the year 1777 and this deponent knows that the said Solter served in the said Regiment from that time until the fall of Charleston when they were separated.

[On May 8, 1821 in Chatham County, Georgia, Thomas Douglass filed another claim as required under the act of May 1, 1820, in which he states that his only property is a black mare valued at \$25; that he is a laborer but by infirmity unable to pursue that occupation and that he has no family.]

[Veteran was pensioned at the rate of \$8 per month commencing December 4, 1818 for service in the South Carolina Continental line for 6 years.]
