Georgia Baldwin County: Personally appeared before me Philip Logan who after being duly sworn, deposeth & saith that he entered into the service of the United States as a muniton [sic, musician] under Captain Temple Cole sometime in the month of May 1776 in which service he continued until the 4th of April 1779 -- when he got a discharge from Lieutenant Colonel James Thaxton [sic, James Thackston] of the 4th Regiment North Carolina Continentals, & that he has lost or mislaid the same so that he cannot possibly come man it -- he further saith that he is a resident citizen of the United States of America and that his reduced circumstances in life., & being nearly worn out with old age, which makes him stand in need of assistance from his Country for support.

Georgia Baldwin County: Whereas I Philip Logan, never having had any pension from my Country, nor never claimed any, I do hereby relinquish, all claims to any, only the pension which I claim and prayed for; agreeable to an act of Congress lately passed, to provide for certain persons, engaged in the land and naval service of the United States during the revolutionary war.

Philip Logan is about 58 years of age and appears to be very infirm, and is destitute of any connections to assist him in his old age. Given from under my hand 30th May 1818

State of North Carolina Secretary's Office 5th of January 1819

I William Hill Secretary of State, do hereby Certify that it appears from the musterroll of the Continental Line of this State, that Philip Logan was in the said establishment as a Musician in the year 1777, in the 4th Regiment under Captain Cole for three years, that he deserted the 12th of September 1777 and was mustered again in January 1779.

Georgia Jones County: Personally came before me Jacob Stilwell¹ and saith on oath that he was acquainted with Philip Logan when in the service of the United States of America for the Space of two years in the years 1776 and 1777 under Captain Temple Cole in the fourth Regiment North Carolina Continentals commanded by Colonel Thomas Polk and James Thaxton Lieutenant Colonel and this Deponent further saith that he was particularly acquainted with him the said Philip Logan as a fifer under me as fife Major in the line and was in the battle at Brandywine and in the battle at German Town with him.
