Pension Application of Thomas Mahorney S38166

Virginia Prince William County to Wit.

On this 22<sup>nd</sup> day of May 1818 before me the subscriber, one of the Judges of the General Court in the state afores'd. personally appeared Thomas Mahorney aged 85 years resident in the County of Prince William in the s'd State being one of the Countys in my judicial Circuit who being by me first duly sworn according to law, doth on his Oath make the following declaration in order to obtain the provision made by the late Act of Congress entitled "An Act to provide for Certain persons engaged in the land and naval service of the United States in the revolutionary war." That he the s'd Thomas Mahorney enlisted in January 1777 in the County of Westmoreland in the state of Virg'a. in the company commanded by Capt. Robert Lovell of the Va. Troops in the Continental Establishment that he continued to serve in the said Corps, or in the service of the United States until the year 177? [last digit 8 or 9] when he was discharged from service in the state of New Jersey that he was in the Battle of Monmouth [28 Jun 1778] – and that he is in reduced circumstances, and stands in need of the assistance of his Country for support, and that he has no other evidence now in his power of his said services.

This day personally appeared before me Wm. Smith a justice of the peace for the County afores'd. Augustine Weedon [pension application S6355] and made oath that Thomas Mahorney served in the last Revolutionary War as a Soldier in the Continental Establishment for one year and that he the s'd. Weedon was in the army with him under Capt. Robert Lovell. Given under my hand & sel this 21<sup>st</sup> May 1818.

Prince William County to wit

On the 3<sup>rd</sup> day of October 1820 personally appeared in open Court being a Court of record for said County Thomas Mahorney aged ninety one resident in said County who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary War as follows: Viz. In the 2<sup>nd</sup> Regiment Commanded by Colo Wm Brent [William Brent] and in the Company Commanded by Captain Quarles and in the Virginia line and the number of the Certificate is Pension No 8654 and that his original declaration is dated on the 22<sup>nd</sup> of May in the year 1818 and the said Thomas Mahorney solemnly swears that he was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that he has not since that time by gift sale or in any manner disposed of his property or any part thereof with intent thereby so to diminish it as to bring himself within the provisions of an act of Congress entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18<sup>th</sup> day of March 1818 and that I have not nor has any person in trust for me, any property or securities, contracts or debts due to me, nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed

Schedule of every article of real or personal Estate belonging To Thomas Mahorney necessary clothing and bedding excepted –

Real property – None – Personal property one old Box, 2 old Chairs, 1 old pot, 2 hoes, the whole estimated to be worth two dollars – and the said Thomas Mahorney declares that he is a planter on a little farm not his, and is rendered unable to pursue it by reason of his age and infirmity and that his family residing with him are as follows: Viz: his wife Maima and his son Jack both of which are slaves, he the said Thomas Mahorney being a free man of colour who served in the war of the Revolution, and is unassisted by the labour of his family
