[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee Washington County: April Sessions 1818


Be it remembered that on the 21st April 1818 Michael Ingle appeared in Open Court in pursuance to an act of Congress entitled an act to provide for certain persons engaged in the land & naval service of the United States in the Revolutionary War and made & subscribed the following declaration on oath that is to say that he the said Michael Ingle was enlisted by Captain Hugh Stephenson into the service of the United States in the Virginia Rifle Regiment or Corps, that he after his enlistment was taken to Boston, and there continued for 12 months the term for which he enlisted and was discharged at Straten Island [sic, Staten Island?], that the date of his enlistment was in July 1775 and his discharge was in July 1776, that he His discharge for many years but owing to the villainy of some person said discharge was with all his papers taken from him by whom & how he never could learn and that he cannot produce his discharge on that account, he further states that he came to the State of Tennessee about thirty years ago, and has resided in Washington County within said state for the whole of said time and that he is so extremely poor that he totally suffers for want of the necessities of life was they not afforded him by the charity of his neighbors as he is very old and infirm, he also states that he has never received any pension from the United States.

Sworn to & subscribed in open court this day above written.

The said Michael also produced in open Court John Ingle who made oath that he saw Michael Ingle enlist under Captain Hugh Stephenson of the Rifle Choir [sic] of Virginia, Riflemen and that he well knows of Michael Ingle being absent after his enlistment for 12 months, and saw him shortly after his return and does verily believe that he served the term of his enlistment.
