## Pension application of Robert Kimble S38896 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

### The State of South Carolina Spartanburg District

On the eleventh day of April 1822 personally appeared in open Court being a Court of Record to wit the Court of General Sessions & Common Pleas for the District aforesaid Robert Kimble of the District aforesaid aged 65 years who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the provision made by the Acts of Congress of the 18<sup>th</sup> March 1818 and the 1<sup>st</sup> May 1820, that he the said Robert Campbell enlisted for the term of two years on or about the 12<sup>th</sup> day of February 1776 in the State of Virginia in the company commanded by Captain Ralph Falkner [Ralph Faulkner], in the fifth Regiment commanded by Colonel Peachy [William Peachy] or Colonel Parker [Josiah Parker] in the line of the State of Virginia on the Continental establishment that he continued to serve in the same Corps until within a month or two of the expiration of the term for which he enlisted – that he reenlisted about that time for the Term of three years in the State of Pennsylvania in the company commanded by the said Captain Falkner after he had reenlisted he obtained a furlough for three months for the purpose of going home to see his friends – when he returned the Company was commanded by Captain William Fowler attached to the said Regiment above mentioned which was commanded by Colonel Ball [Burgess Ball] afterwards commanded by Colonel Gaskin [Thomas Gaskins] – Afterwards the 5<sup>th</sup> Regiment to which he was attached was reduced to the 3<sup>rd</sup> Regiment commanded by Colonel Heath [William Heth] in a short time afterwards commanded by Colonel John Navils [John Neville] during which time he was in the battles of Trenton [December 26, 1776], Princeton [January 3, 1777], Brandywine [September 11, 1777], Germantown [October 4, 1777], Monmouth [June 28, 1778], Stony Point [July 16, 1779], Powlers Hook [Paulus Hook, August 19, 1779] and also the siege of Charleston [Charleston fell May 12, 1780] in this State where he was taken prisoner by the British; That he was detained as a prisoner by them for about fourteen months – nine months of which time he was confined in a prison Ship in the Harbor of Charleston from which place he was transported to old James town in the State of Virginia then landed, marched to Williamsburg, exchanged & regularly discharged by Major Stephens & Captain Blackwell, having when discharged served over the term for which he enlisted upwards of four months – having been in the service in the last Enlistment three years and upwards of four months – that he was discharged in the year 1781 at Williamsburg in the State of Virginia by Major Stephens or Stevens & Captain Blackwell as aforesaid that he lodged his discharge in the office in Richmond for the purpose of obtaining his land Patent, by doing which he was informed it would be procured. But that his discharge has never been returned to him neither has he ever received his patent or Grant for the land to which he is entitled that he

has no further testimony in his power or possession of his services in the Revolutionary War but the affidavits of Thomas Kimbell<sup>1</sup> which are here with exhibited. And in pursuance of the act of the first of May 1820, he solemnly swears that he was a resident Citizen to a good done of the United States on the 18<sup>th</sup> day of March 1818 and that he has not since that time by gift, sale or in any manner whatever disposed of his property or any part thereof with intent thereby so to diminish it as to bring himself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that he has not nor has any person in trust for me any property, or securities, contracts or debts due to him nor has he any income other than what is contained in the schedule hereto annexed and by him subscribed

The declarant further saith that he is a farmer by occupation that he is aged & infirm his Constitution having been much impaired during his service & imprisonment during the Revolutionary War that he has in family Fanny Kimble his wife between 46 & 50 years of age & quite infirm, Archibald Kimble his son about 19 years of age very small, sickly & incapable of doing any kind of work to support himself – Nancy Kimble a Daughter 17 years of age, she also infirm – Martha a daughter 15 years of age sickly & infirm

Sworn to & declared on the 11<sup>th</sup> day of April in open Court S/Robert Kimble

[Veteran was pensioned at the rate of \$8 per month commencing April 11, 1822, for service as a private in the Virginia Continental line.]

### [From bounty land records in the Library of Virginia]

I do certify that Robert Kimble a soldier of Colonel John [paper damaged and text illegible] Detachment of the Virginia Line has served the full Term of Three years for which he was enlisted and is now hereby discharged from the Service; that he has received his pay [paper damaged and text illegible] Continental currency up to the first day of December 1779 since which time he only received \$2 in Specie from the [paper damaged and text illegible] Commissary of prisoners in Charles Town
