[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]


South Carolina Sumter District

Personally appeared in the Court of Equity for the said District Thomas Kolb who upon being duly sworn upon oath and declared that sometime in the latter end of February or beginning of March in the year 1776 he enlisted in the Revolutionary War of the United States of America as a Private Soldier for the Term of fifteen months under Captain Thomas Potts in the Fifth Regiment commanded by Colonel Isaac Huger in the Continental Establishment in the South Carolina Line. That he continued & performed the duties of a soldier in the service in which he Enlisted during the Term of time aforesaid and was regularly Discharged. That during the said Term of service he was in the Battle of Stono [June 20, 1779]<sup>1</sup> and was stationed in Charleston when Sir Peter Parker made the attack on Sullivan's Island on the 28th day of June [1776]<sup>2</sup> in the year above mentioned. That this Deponent is in reduced Circumstances and stands in need of the assistance of his Country for support.

Personally appeared in the Court of Equity for the said District Thomas Garrett Senior<sup>3</sup> who upon being duly sworn made oath and declared that he does to his own knowledge know of that Thomas Kolb did Enlisted as a Private Soldier under Captain Potts sometime in the spring of the year of our Lord 1776 for the term of fifteen months in the Regiment commanded by Colonel Isaac Huger being the Fifth Regiment in the South Carolina Line in the Continental Service of the United States of America. That he did continue in said service during the time of his Enlistment and was lawfully discharged.

That the said Thomas Kolb is an aged man, is in reduced circumstances & stands in need of the assistance & benevolence of his Country for Support.

Sworn to in open Court this 18th February 1819




