[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]


South Carolina, Edgefield District

On this eighth day of June 1819 before me one of the Judges of the Court of Equity for the District and State aforesaid personally appeared Julius Deen – aged seventy-five years resident on Cuffee Town Creek [Coffee Creek ?] in the Said District, who being by me first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress Entitled “An act to provide for certain persons engaged in the Land and naval service of the United States in the Revolutionary War,” that he the said Julius Deen enlisted in Halifax County in the State of Virginia on the ___ day of November in the year 1775 in the company commanded by Captain Nathaniel Cock of the Seventh Regiment of Continental Regulars that he continued to serve in said Corps or in this last mentioned service of the United States for twelve months, when he was discharged from service in Prince William County in the State of Virginia which discharge he has lost or mislaid that he cannot procure [it]. That afterwards being discharged from the aforesaid enlistment, he again enlisted in January 1777, in the company commanded by Captain John Bard of the Second Regiment of Continental Regulars, commanded by Colonel Samuel Elbert, and that he continued in the said service for upwards of two years and until made a prisoner at Savannah [the British captured Savannah on December 29, 1778]. And that he was in the battles of Gwin's [sic, Gwynn Island, July 8-10, 1776] Island-- and at the capture of Savannah at which last place he received a slight wound, and that for the proof of the last mentioned service and enlistment in Georgia he submits the annexed affidavit But that he has no other evidence of his enlistment and service in Virginia than this his oath. That he is in reduced circumstances and stands in need of the assistance of his Country for support.

South Carolina, Edgefield District:

Personally came before me Richard Burton¹ of the district & State aforesaid a pensioner under the act of Congress of March 18, 1818, who swears that he knew Julius Dean whilst he was a soldier of the United States Army in the Georgia line under General Samuel Elbert, that he was enlisted, he does not know in what state, that he verily believes that he served in Georgia

principally for the space of 3 years, and that he verily believes that for the whole time he acted as a faithful soldier from the year 77 and onward – That it was on the Continental establishment in the revolutionary Army.

State of South Carolina, Edgefield District

On this fifth day of October 1820 personally appeared in open Court being a court of record for the said district and State Julius Deen age 76 years resident on the waters of Cuffee town Creek in said District who being first duly Sworn according to law doth on his oath declare that he served in the Revolutionary War as follows (Viz.) in the seventh Regiment of the Virginia Line Commanded by Colonel Dangerfield in a company commanded by Captain Nat Coke that he is now on the pension roll of virtue of the act of Congress of the 18th of March 1818 that his certificate for a pension is dated on the seventh of July 1819 that his pension commenced on the 8 June 1819 and that he had already received from that period till the fourth of March 1820 and he does solemnly swear that he was a resident Citizen of the United States on the 18th of March 1818 and that he has not since that time by gift, sale or in any manner disposed of his property or any part thereof with intent thereby so to diminish it as to bring himself within the provisions of An Act of Congress entitled “An Act to provide for certain persons engaged in the land and naval Service of the United States in the Revolutionary War,” passed on the 18th day of March 1818; and that he has not, nor has any person in trust for him, any property or securities, contracts or debts due to him, nor has he any income or roll state personal or private except his clothes which are not necessary to be given and that he is exceedingly infirm that he is often bed ridden and unable to pursue his formal occupation of a farmer that he has six children all of the age and acting for themselves exclusively and that he has no one to whom he can look or from whom he can expect Support if his pension is withheld from him.
