
Pension Application of Nathaniel Price S40295 NY [NJ]

State of Ohio } On this 29th day of July, anno Domini one thousand eight hundred and
Belmont County } eighteen, before me the subscriber, the President Judge of the fifth Circuit
of the Court of Common Pleas for the State of Ohio, personally appeared
Nathaniel Price, aged sixty four years, on the fifteenth day of January anno Domini 1818, resident in the
County of Belmont and State of Ohio aforesaid, who being by me first duly sworn, according to law,
doth, make the following declaration, in order to obtain the provision made by the late act of Congress,
intituled "an act to provide for certain persons engaged in the land and naval service of the United States,
in the revolutionary war"

That he the said Nathaniel Price, enlisted in the State of New jersey during the war, in the Company
commanded by Cap. Samuel Huff, [Samuel Hough] on the first day of February anno Domini 1777; that
he was some time after his enlistment returned to New york to fill up the second or Newyork artillery
regiment, commanded by Col. John Lamb, when he received the office of Gunner; that he continued to
serve in the service of the United States untill the ninth day of June 1783, when he was discharged at
Head Quarters, by Gen. George Washington, on the said ninth day of June 1783.

that he was in the battles of the three rivers [Trois-Rivieres, Quebec, 8 Jun 1776] Short hills [26 Jun
1777], Brandywine [11 Sep 1777], Germantown [4 Oct 1777], White plains [28 Oct 1776], Monmouth
[28 Jun 1778] and the surrender of Cornwallis [at Yorktown, 19 Oct 1781], and that he is in reduced
circumstances, and stands in need of the assistance of his Country for suport
Sworn to and declared before me, the day and year aforesaid.





BY HIS EXCELLENCY GEORGE WASHINGTON, ESQ;

THESE are to CERTIFY that the Bearer hereof Nathaniel Price Gunner in the 2 or New york Artillery
Regiment, having faithfully served the United States from 1st Feb'y. 1777 until the present period and
being inlisted for the War only, is hereby DISCHARGED from the American Army.

GIVEN at HEAD-QUARTERS the Ninth day of June 1783

THE within CERTIFICATE shall not avail the Bearer as a Discharge, until the Ratification of the
definitive Treaty of Peace; previous to which Time, and until Proclamation thereof shall be made, He is
to be considered as being on furlough.

State of Ohio Belmont County Ss

At a court of Common Pleas begun and held at St Clairsville in and for the County of Belmont on the Twenty fourth day of July 1820 before the Honourable Benjamin Tappan Esquire President of the fifth circuit of the Courts of Common Pleas and Edward Bryson John Wiley and Joseph Anderson Esquires associate judges of the said Court. On The Twenty eighth day of July AD 1820 personally appeared in open court being a court of Record for said County in the said Circuit Nathaniel Price aged sixty six years resident in Belmont County in the said circuit, and being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provisions made by the acts of Congress of the 18th of March 1818 and the 1st of May 1820

that he the said Nathaniel Price enlisted for one year in the company commanded by Captain Joseph Baily in the Second Regiment of New Jersey commanded by Colonel William Maxfield [sic: William Maxwell] to got to Quebeck and after the year elapsed he was discharged by General [Horatio] Gates at Ticonderoga in November 1776 in the state of New York But he received no written or printed discharge That on his return home the said Nathaniel Price again enlisted for and during the War on the 17th of February 1777 in the State of New Jersey in the company commanded by Captain Samuel Hull of the second Artillery Regiment of New York commanded by John Lamb in the line of New York being transferred from the New Jersey line to fill up John Lambs Regiment That he continued to serve in the said corps on the continental establishment until the end of the War when he was discharged the 9th of June 1783 at West point in New York by written discharge now at War department.

That his declaration now at the War department was dated the 29th of July 1818 upon which he received a certificate Numbered 9915 That he was in the battles of the Three Rivers the battle of Short Hill the battle of Brandywine the battle of Germantown the battle of Monmouth and at the taking of Lord Corn Wallace. And that he has no other evidence now in his power of his said service.

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled “an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War” passed on the 18th day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed.

The occupation of the said Nathaniel Price is a weaver but is unable to follow it by reason of old age and the wounds he received in the head and his knees in the War. That his family consists of himself his wife an old woman unable to work and Three others One daughter Elizabeth aged Twenty nine years who is able to work and who is the main support of the family Two poor Grand children one of the age of seven years whose name is Ephraim Burch and Mary Burch aged about Three years The Father of these children has absconded some years and is a poor drinking creature.
