State of North Carolina Bertie County: SS

On the last day March 1820 before me the Subscriber one of the Judges of the Superior Courts of Law & Equity for the said State personally appeared Evans Archer aged 65 years resident in Hertford County in the said State, who being by me first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provisions made by the late act of Congress, entitled "An Act to provide for certain persons engaged in the Land & naval service of the United States in the revolutionary War." That he the said Evans Archer enlisted for the term of 18 months about the month of August in the year 1780 at Portsmouth in the State of Virginia in the company commanded by Captain John Anderson of the Regiment commanded by Colonel Matthews in the line of the State of Virginia on the Continental establishment, that he continued to serve in the said Corps, or in the service of the United States until the end of 18 months when he was discharged from service at Salisbury in the State of North Carolina and that he was in the Battle of Eutaw

And that he is in reduced circumstances & stands in need of the assistance of his country for support: and that he has no other evidence than as above stated now in his power of his said services.

I James Smith do depose and say that I believe the statement of evidence Archer hereto before set forth as to his service in the Revolutionary War is correct. This Deponent was a soldier and served with said Evans Archer at or near the Eutaw and also at Santee in South Carolina.

State of North Carolina, Hertford County: Superior Court of Law held for said County at the Court House in Winton on the fourth Monday of September A.D. 1823

On the 27th day of September in the year 1823, personally appeared in open Court (being a

Court of Record for the County aforesaid and proceeding according to the Course of the Common Law with a Jurisdiction unlimited in point of amount keeping a record of its proceedings and having the power of fine and imprisonment) Evans Archer aged about sixty nine years resident of the said County of Hertford who first being duly Sworn according to Law, doth on his Oath make the following declaration in Order to obtain the provision made by the act of Congress of the 18th of March 1818 and first of May 1820, that he the said Evans Archer enlisted as a Soldier for the term of eighteen months about the month of July 1780 at Portsmouth in the State of Virginia in the Company commanded by Captain John Anderson in the Regiment Commanded by Colonel __ Campbell which this deponent believes to have been the first Regiment in the line of the State of Virginia on the Continental establishment, that he continued to serve in the said Corps or in the Service of the United States until sometime in the month of January in the year 1782 when he was honorable [sic] discharged from the said Service (his time of enlistment having expired) in the town of Salisbury in the State of North Carolina, that he was in the Battle at Eutaw Springs South Carolina and at the Siege of ninety Six, that he has no other evidence than that hereto annexed whereby to prove his said Services. And in pursuance of the said act of Congress of the first of May 1820, I the said Evans Archer to Solemnly Swear that I was a resident Citizen of the aforesaid County in the United States on the 18th day of March 1818 and that I have not since that time by gift, Sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of the act of Congress entitled "an act to provide for certain persons engaged in the land and naval Services of the United States in the Revolutionary war" passed on the 18th day of March in the year 1818 and that I have not nor has any person in trust for me, nor [do I] have any property or Securities Contracts or debts due to me, nor have I any income, other than the little pittance I earn by my manual labor, and that which proceeds from acts of Charity that I have no property Save by wearing apparel which is of Small Value and consequently no Schedule of property to render. The said Evans Archer further saith that he is a farmer by occupation unable to work but little by reason of bodily infirmity and an injury some years since received in his right Shoulder and that he has no family, that he resides with Margaret Archer his daughter a single woman who is poor and Scarcely able to Support herself and her child about four years old. The said Evans Archer further say as that for some years past he has began so much a Cripple and infirm as to be able to do but little towards his Support and has been and now is greatly dependent upon Charity for the few necessities of life which are afforded him.

The said Evans Archer moreover States that he made his first declaration in order to attain a pension under the said act of Congress of the 18th of March 1818 before the Honorable John R. Donnell then and now one of the Judges of the Court aforesaid on the last day of March in the year 1820.

Sworn to Subscribed and declared by the said Evans Archer in Open Court this 27th day of September A.D. 1823.

I Martin Bizzell do depose and say that I believe the Statement of Evans Archer herein set forth as to his Services in the Revolutionary War is Correct and true. This affiant well remembers that he was told by an officer in the Survey that he had enlisted the said Evans Archer and from his absence for some time afterwards and General and uncontradicted report to that effect he has no doubt of the fact of his enlistment and services in the regular Army of the United States during the said Revolutionary War.

State of North Carolina Hertford County: Court of Pleas & Quarter Sessions, Held for said County the

4th Monday in November 1823

On this 28th day of November 1823 personally appeared in open Court being a Court of record for the said County, and proceeding according to the Course of the Common Law, with a jurisdiction unlimited, in point of amount keeping a record of its proceedings and having the power of fine and imprisonment, John Weaver aged about 65 years maketh oath that Evans Archer who has made an affidavit for a pension in Hertford Superior Court of Law, was a Soldier in the Revolutionary War, that he the said Evans Archer served in the same Regiment with this deponent, Commanded by Colonel Campbell, that this deponent saw said Evans Archer at Ninety Six in the State of South Carolina about fifteen days before the Engagement and this deponent further deposeth that he saw the said Evans Archer after the Engagement in said Corps discharging the duties of a Soldier.
