[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

District of North Carolina: SS

On the 17th day of August 1819, before me the subscriber, one of the Judges of the United States for the District aforesaid, personally appeared Hardee Carrol aged sixty years or thereabouts resident in Duplin County in the said District, who being by me first duly sworn, according to law, doth on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the land & naval service of the United States in the revolutionary war." That he the said Hardee Carrol, on or about the 1st day of August 1782, cleared a class for a bounty, & entered the service of the United States, by turning out for said class, in Duplin County & State of North Carolina, for the term of eighteen months, & was then & there received & enrolled in the company commanded by Captain Joseph T Rhodes, of the first Regiment in the North Carolina line on the Continental establishment, in the said revolutionary war; that he continued to serve in the said company, Regiment & Line, until the month of July 1783, making about eleven months actual & continued service, when he was on James Island, South Carolina, where the Army was discontinued, & he is brought around by water to Wilmington, in the State of North Carolina, with his said Captain, at which latter place he received his furlough & was never after called into service – that the said furlough is lost – that he was in no battles – and that he is in reduced circumstances & stands in need of the assistance of his country for support. Sworn to & declared before me the day & year first aforesaid.

State of North Carolina Duplin County: Hardee Carrell being duly sworn saith that he served as a Soldier in time of the Revolution war in the first Regiment the line of this State on the Continental Establishment in Captain Joseph T Rhodes' Company which Company he joined on or about the first day of August 1782 for the term of eighteen months and served until July or August in the year 1783 when I was furloughed and not called into service again until the Army was finally discharged.




State of North Carolina,

State of North Carolina Duplin County: On this 17th day of October 1820 Personally appeared in open court being a court of record Hardee Carrol aged sixty-one years resident in said County of Duplin, who being first duly sworn according to law, doth on his oath, declare that he served in the revolutionary wars as follows (viz.) 11 or 12 months in the 1st or 10th Regiment in Captain Joseph T Rhodes' Company and that he made application for a pension on the 17th of August 1819 and obtained a Certificate No. 14940. And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed (viz.)

I and I do further say that my family consists of a wife aged about 56 years, three daughters aged 23, 28 & 18 years and that I have no occupation but that of a common laborer. Sworn to and declared on the day and date above written.

I William Hill Secretary of State in & for the State aforesaid, do hereby certify that it appears from the musterrolls of the North Carolina Continental line for the Revolutionary war, that Hardy Carrell was mustered as a private soldier in said line in Captain Rhodes's Company of the 10th Regiment on the first of December 1782 for the term of eighteen months. The date of

his discharge not mentioned.
