[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

Edward Harvey aged about Sixty-Six years now living in Clermont County State of Ohio Personally appeared before me one of the Associate Judges in and for the aforesaid County and being sworn depose and saith that he served four years and about six months a Soldier in the Revolutionary War in the United States Army, entered into the Army in 77, under Captain Clainmore [Cleon Moore] the said Captain got wounded in the hip in the Battle at Brandywine [September 11, 1777] then served under Captain Joseph Smith while remaining at the North which was 3 years, this was in the 16<sup>th</sup> Regiment of the Virginia line. My time being out I was discharged from the Army in Philadelphia in the year 1780, then I entered the Army again at Petersburg Virginia under Captain Seldon [possibly Samuel Selden] thence marched to North Carolina and was in the Battle at Guilford Courthouse [March 15, 1781] Colonel Green [John Green] Commander of the Regiment I was in an General Green [Nathanael Greene] Commander from this I was in several Battles and got wounded at the Eutaw Springs [September 8, 1781] a ball went through his leg just below the knee. These facts was sworn to and subscribed before me on the 20<sup>th</sup> day of May 1818.

State of Ohio Hamilton County: SS

Edward Harvey aged Sixty seven years being duly sworn on the holy Evangelists depose and saith that in the year of our Lord 1770 he enlisted as a soldier in the American Army in the company commanded by Captain Clean Moore then in Alexandria Virginia in the 16<sup>th</sup> Regiment commanded by Colonel William Grason [William Grayson] in the Virginia line on the Continental establishment; that he enlisted for the term of three years and served and continued in the same company during the three years aforesaid at the expiration of which time he received his discharge from Colonel Feebecker [Christian Febiger] which discharge together with the certificate of Captain Joseph Smith this Deponent has lost. This Deponent was in the Battles of Brandywine, Germantown [October 4, 1777], Monmouth [June 28, 1778], Guilford, Campden [probably Battle of Hobkirk Hill, April 25, 1781] and the Eutaw Springs in which last battle this Deponent was wounded by a musket ball through the knee and has been disabled from

doing any active business ever since by means of said wound and from his reduced circumstances this Deponent is unable to support himself and stands in need of his country for support.

The State of Ohio Clermont County: SS

On this 14<sup>th</sup> day of August 1820 personally appeared in open Court – to wit the Court of Common Pleas for said County – being a Court of Record – as having the power of fine and imprisonment = Edward Harvey aged seventy years resident in said County, who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary War as follows to wit in the 16 Regiment in the Virginia State line on Continental establishment commanded by Colonel William Grayson in the Company commanded by Captain C. Moore – that deponent was notified of his being in scribed on the pension list roll of the Ohio Agency at \$8 per month commencing the 16<sup>th</sup> day of April 1818 by pension certificate dated 25<sup>th</sup> May 1819 – Numbered 11.022 & I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled “an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war” passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

And further this Deponent saith he is a farmer by Occupation but from age and the effects of wounds received in the war of the revolution he is entirely unable [to] support himself by work – & without public or private munificence – or the aid of his government he could not get the necessaries of life – he has none in family except Mary his wife who is aged 66 years and is very infirm & unable to work for her support.

[Veteran was pensioned at the rate of \$8 per month commencing April 26, 1818 for service as a private for 3 years in the Virginia Continental line.]

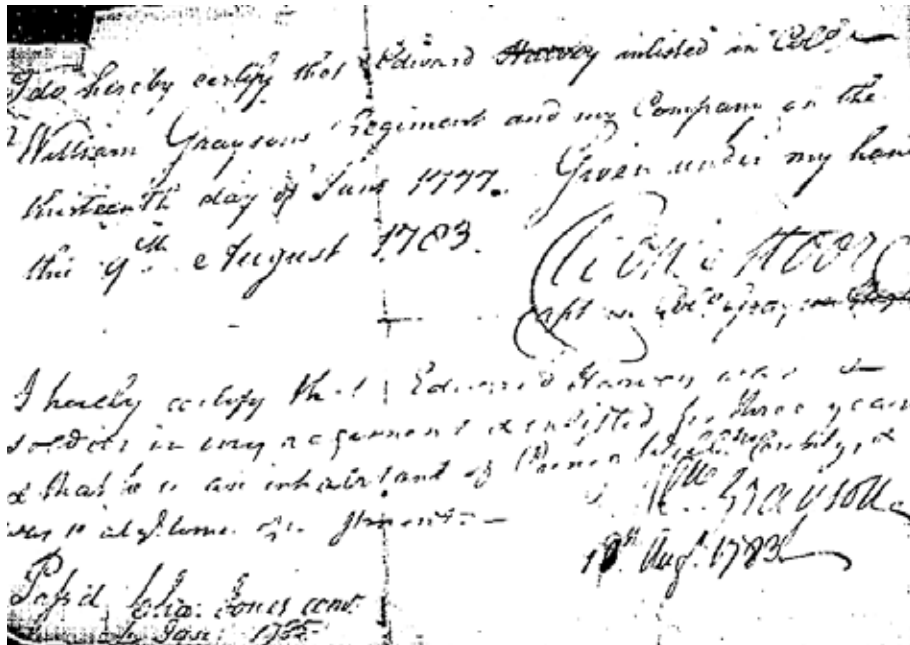
